A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA, COMMITTING TO FUND OPERATIONS AND MAINTENANCE FOR PEMBROKE ROAD FROM DYKES ROAD TO US 27; DIRECTING THE APPROPRIATE CITY OFFICIALS TO TAKE ANY AND ALL ACTION NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Cities of Pembroke Pines and Miramar are collaborating on a regional Project (the "Project") to widen and extend Pembroke Road and extend Miramar Parkway to Pembroke Road to enhance regional transportation mobility and emergency access in western Broward County; and

WHEREAS, the Project includes the widening and extension of Pembroke Road from Dykes Road to U.S. 27, as well as the extension of Miramar Parkway to connect with Pembroke Road; and

**WHEREAS**, the Project is currently in the design phase, with construction expected to begin in FY2026; and

WHEREAS, upon completion of construction, the City of Pembroke Pines will be responsible for maintaining the elements of the project that fall within its jurisdictional boundaries, including roadway pavement, sidewalks, shared-use paths, drainage systems, swale landscaping, and irrigation; and

WHEREAS, the City Commission finds that committing to fund the operation and maintenance of the improvements to Pembroke Road is in the best interests of the health, safety, and welfare of the citizens and residents of the City

**Section 7**. This Resolution shall become effective immediately upon its passage and adoption.
