AN EMERGENCY ORDINANCE OF THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA, PURSUANT TO SECTION 3.13 OF THE CITY'S CHARTER AND SECTION 166.041, FLORIDA STATUTES, APPROVING AND AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE THE FIFTH AMENDMENT TO THE AGREEMENT TO ENTER INTO SUB-SUBLEASE WITH HG PINES, LLC; PROVIDING FOR CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, on June 11, 2024, the City and HG Pines, LLC entered into an Agreement to Enter into Sub-Sublease ("Original Agreement"); and

WHEREAS, the parties deem it necessary to extend the term of the Review Period of the Original Agreement, as amended, prior to July 31, 2025, which is the current deadline for the Review Period; and

WHEREAS, the City Commission of the City of Pembroke Pines, Florida, deems it to be in the best interests of the public to adopt this Emergency Ordinance and approve and authorize the execution of a Fifth Amendment to the Agreement to Enter into Sub-Sublease with HG Pines, LLC to extend the Review Period under the Original Agreement, as amended prior to July 31, 2025, and in accordance with Section 3.13 of the City's Charter and Section 166.041, Florida Statutes.

SECTION 1. The foregoing "WHEREAS" clause is hereby ratified and confirmed as being true and correct and is hereby made a specific part of this Ordinance.
