A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA, APPROVING A DRAINAGE EASEMENT AGREEMENT WITH THE SOUTH BROWARD DRAINAGE DISTRICT THE PEMBROKE FOR ROAD EXPANSION PROJECT; AUTHORIZING THE CITY MANAGER то EXECUTE THE AGREEMENT; PROVIDING FOR CONFLICTS: PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Pembroke Road Expansion & Miramar Parkway Extension project (the "Project") runs through portions of both the City of Pembroke Pines and the City of Miramar (hereinafter, collectively referred to as "Cities"); and

WHEREAS, the Project includes the construction of drainage facilities to provide drainage from the Pembroke Road Right-of-Way to the adjacent lake; and

WHEREAS, the South Broward Drainage District has jurisdiction over the lake; and

WHEREAS, the City of Pembroke Pines will receive certain drainage improvements as part of the Project and requires a drainage easement from the South Broward Drainage District, in order to maintain those improvements; and

WHEREAS, the City of Miramar is responsible for the construction of the drainage facilities associated with the Project, including areas within Pembroke Pines right-of-way; and

WHEREAS, after construction is complete, the City of Pembroke Pines

will be responsible for the maintenance of the drainage facilities associated with the Project that are located within City of Pembroke Pines right-of-way; and

WHEREAS, the City Manager recommends that the City Commission approve the Drainage Easement Agreement, and authorize the City Manager to execute the Agreement, in the form attached hereto as Exhibit "A"; and

WHEREAS, the City Commission finds that approving the Drainage Easement Agreement is in the best interests of the health, safety, and welfare of the citizens and residents of the City of Pembroke Pines.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA AS FOLLOWS:

Section 1. The foregoing "WHEREAS" clauses are ratified and confirmed by the City Commission.

Section 2. The City Commission of the City of Pembroke Pines, Florida, hereby approves the Drainage Easement Agreement, as more fully descried in Exhibit "A", for the improvements associated with the Project.

Section 3. The City Commission authorizes the City Manager to execute the Drainage Easement Agreement in the form attached hereto as Exhibit "A", together with such non-substantive changes as are deemed acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.
