**A RESOLUTION OF THE CITY OF PEMBROKE PINES, FLORIDA ADOPTING THE BUDGET FOR THE CITY OF PEMBROKE PINES CHARTER SCHOOLS SPONSORED BY THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA FOR THE CHARTER SCHOOL FISCAL YEAR BEGINNING JULY 1, 2022 IN THE AMOUNT OF \$62,330,460; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Fiscal Year for the City of Pembroke Pines Charter Schools (“Charter Schools”), begins July 1, 2022 and ends June 30, 2023; and

**WHEREAS**, a Budget for the revenues and expenditures of the Charter Schools for the Fiscal Year of the Charter Schools, sponsored by The School Board of Broward County, Florida has been prepared by the City Manager for approval by the City Commission;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA THAT:**

**SECTION 1.** The foregoing “WHEREAS” clauses are hereby ratified and confirmed as true and correct and by this reference incorporated herein.

**SECTION 2.** The Charter Schools’ Budget, totaling \$62,330,460 which is more specifically attached hereto as **Exhibit “A”** and expressly made a part hereof, is hereby adopted and shall be in full force and effect for the Fiscal Year of the City of Pembroke Pines Charter Schools commencing July 1, 2022.

**SECTION 3.** The funds appropriated for the expenditures designated in the Budget include state-shared revenues received from the State of Florida, federal and state grants as well as contributions received from various benefactors.
