### **2.5 Grant/Federal Funding**

Yes, the City plans to utilize the following grant(s)/federal fund(s) for this project:

Federal Communications Commission's (FCC) E-Rate program to receive funding from the Universal Service Fund. The E-Rate program provides discounts for telecommunications, Internet access, telecom devices, and internal connections to eligible schools and libraries. After the bid goes through a competitive bidding process that complies with FCC rules and state and local procurement requirements, the Universal Service Administrative Company (USAC) issues funding commitments to eligible applicants. Discounts range from 20 to 90 percent and are based on the poverty level of the schools.

## **SECTION 3 - PURPOSE AND BACKGROUND**

### **3.1 Purpose**

The City of Pembroke Pines is seeking bids from qualified firms, hereinafter referred to as the Contractor, to provide the requested Cisco infrastructure hardware needed for a planned network equipment upgrade, in accordance with the terms, conditions, and specifications contained in this solicitation.

### **3.2 Background**

Pembroke Pines, Florida, ranked as the eleventh largest city among the state's four hundred plus municipalities and the second largest in Broward County, maintains a welcoming small-town ambiance that resonates with its residents. Located conveniently in southwest Broward County, the city provides seamless access to major highways, employment centers, entertainment venues, parks, golf courses, and a diverse array of dining and shopping options.

With a population of approximately 170,000 residents spread across 32.68 square miles, Pembroke Pines is renowned as one of the best cities to live in America. The city boasts 28 superior parks, lush landscaping, and a distinctive South Florida charm that contributes to its natural beauty. Notably recognized as 2024's Best Place to Raise a Family in Florida, and 2024's Best City of Hispanic Entrepreneurs by WalletHub, Pembroke Pines also earned a place as the on Money Magazine's esteemed Best Places to Live list in 2014, as the sole Florida representative, ranking in at #32 in the nation.

Incorporated in 1960, Pembroke Pines is celebrated as a safe and desirable community, having received accolades such as the All-America City designation. The city's commitment to arts and culture, exceptional schools, diverse population, numerous parks, and forward-thinking approach in an ever-evolving world make it a standout destination.

Pembroke Pines is also the home to the largest municipal-run charter school system in the nation, serving over 6,000 students across five separate campuses. The City's award-winning charter school system is located in the Broward County School District, which is the sixth largest school district in the nation.



## **SECTION 4 - SCOPE OF WORK**

### **4.1 Required Documentation**

- Vendors **must** have an active USAC SPIN (Service Provider Identification Number) in order to be eligible for consideration.

### **4.2 Definitions**

Definitions for this Section:

- "Applicant" means the entity applying to the E-Rate program. For the purposes of this solicitation, "applicant" refers to The City.
- "Service Provider" means the entity responsible for producing the hardware requested by The City. For the purposes of this solicitation, "service provider" refers to the vendors submitting bids.

### **4.3 Invoicing Method**

Service providers file the FCC Form 474 or Service Provider Invoice (SPI) Form after billing the applicant for the non-discounted amount (the non-discounted amount is the applicant's financial responsibility). Service providers are reimbursed by USAC for the discounted amount. Under the SPI method:

- Applicants are **billed by the service provider for the cost of the non-discounted portion** of the eligible equipment and services listed on the SPI form. Applicants do not pay the service provider for the discounted portion invoiced to USAC.
- After the provider has billed the applicant, the provider submits an SPI form for the discounted amount.
- USAC reviews the invoice and pays the service provider if payment is approved.

By submitting a bid vendor agrees to accept this invoicing form of payment.

### **4.4 Hardware Requested**

- The City is requesting pricing for several possible network configurations and will evaluate which hardware combination is in the City's best interest.
- Please be advised that the City is requesting pricing for both the Cisco C9200 and Cisco C9200-L switch options. A decision on which option to select will be made after reviewing the pricing obtained through the bid process.
- Per Section 9.9, The City is not obligated to contract for a given amount of commodities/services subsequent to the award of this solicitation. The City reserves the right



to issue separate purchase orders as needed, issue a blanket purchase order, and release partial quantities, or any combination of the preceding as deemed necessary by the City.

- The City is requesting pricing for the hardware in the table below. Proposals should be for hardware **only**. No services (e.g., installation, configuration, or maintenance) should be included in the price proposed.
