## **4:00 PM REGULAR MEETING CALLED TO ORDER**

### **ROLL CALL**

Also present: City Manager Charles F. Dodge, City Attorney Samuel Goren, and City Clerk Debra E. Rogers.

Commissioner Schwartz was absent from the Special Emergency Meeting.

### **PLEDGE OF ALLEGIANCE**

Vice Mayor Hernandez led the Pledge of Allegiance.

### **ORDINANCES AND RESOLUTIONS:**

#### **FIRST READING ORDINANCES:**

Mayor Castillo opened the Emergency Meeting by explaining its purpose which was to address the approaching expiration of the future sale agreement for Pines Place. He shared that the city had undertaken a wide-ranging effort, including a trip to Tallahassee, to gain legislative support for the deal, despite previous challenges. The mayor said the initiative would significantly benefit the City of Pembroke Pines, its residents, business partners, and the State of Florida by expanding access to affordable housing. He commended the City Manager, City Attorney, and Tallahassee representatives for successfully resolving the tax exemption issue and then introduced City Attorney Goren to provide further details.

City Attorney Goren explained that the relevant tax provision was embedded in the State of Florida's annual tax bill, specifically in Section 18, page 19 of Chapter 2025-208. This new provision, Section 196.19781, was the result of collaborative efforts between the Mayor, City Commission, and other stakeholders. It outlined key terms supporting affordable housing, which was set to expire on July 31, 2025, prompting the need for the Emergency Meeting.

City Attorney Goren further explained that Hayden Glades, a partner in the affordable housing effort, was present at the meeting. He stated that all inspections and related items were due to expire by July 31, 2025, but would be extended through December 31, 2025, or sooner, in accordance with the sub-sublease agreement between the City and Hayden Glades. He also referenced the upcoming Fifth Amendment to the agreement, which defined affordable housing according to State Statute. Specifically, the income classifications outlined in Chapter 420 of the Florida Statutes (very low, low, or moderate income). These standards would remain in effect for the duration of the sub-sublease.

Mayor Castillo concluded by expressing his support for the City's continued role in qualifying applicants for workforce housing, especially prioritizing police and fire department personnel. He noted that the City would inform the Commission of any unit vacancies, and appropriate waitlists would be developed to ensure compliance with legal requirements and prioritization standards.
