2022: Retired after 32 years of honorable Federal service.

2014-2022: Assigned to the Asset Identification and Removal Group (AIRG) with case management of numerous asset forfeiture investigations, the objective of seizing real estate, bank accounts, and other tangible assets of violators. Case agent for the matter of Bartolo Hernandez and Julio Estrada, who profited from the smuggling of Major League Baseball players Jose Abreu, Adeiny Hechevarria, Yasiel Puig, Yuli Gurriel, and Leonys Martin, all of Cuban origin. Provided numerous training presentations to, and ongoing consultations with, other Federal, state and local law enforcement agencies regarding asset forfeiture law, policy and strategies.

2014: Assigned as the Parole and Benefits Coordinator. Responsible for drafting various forms of relief and obtaining benefits (such as work authorization) for cooperating defendants and those in an irregular immigration status, such as Deferred Action, Parole or Advanced Parole for both HSI and numerous other Federal, state, and local agencies. Worked with the Undercover liaison to procure immigration benefits in a discrete and secure manner to avoid retaliation against cooperating defendants or witnesses. Worked closely with the office Victim and Witness Coordinator to apply for and obtain "T" (victims of human trafficking) and "U" (victims of general criminal activity) visas. Drafted and advocated for "S" (LPR for informants and at grave risk for retaliation) visa applicants.

2013-2014: Assigned to Marine Group investigations. Responsible for developing leads and subsequent intelligence with respect to narcotics smuggling activity on the Miami River (a historical bastion of such activity regarding marine vessels from Haiti and the Dominican Republic). Conducted numerous surveillances coordinated with the U.S. Coast Guard, as well as state and local law enforcement, to identify and interdict malevolent actors involved in the smuggling of contraband.

2011-2013: Re-assigned to JTTF, assuming prior responsibilities with seamless cooperation with the FBI regarding the development of information, investigation, and proactivity in thwarting threats to U.S. safety and security across multiple platforms (e.g., infrastructure, travel modalities, etc.). Assisted JTTF-Boston regarding local (Miami) leads related to the Boston Marathon bombing of 2013.

- 2009-2011: Assigned to HSI headquarters in Washington, DC. From 2009 to 2010, Acted as a Program Manager for human rights investigations, focusing on child soldier utilization the Liberia-Sierra Leone conflict, aiding agents and the United States Attorney's Office in the Buffalo, NY in securing funding and logistical support for their work. Also provided similar assistance to agents in Newark, New Jersey, San Diego, California, and trial attorneys at main Department of Justice with respect to investigations pertaining to the Rwandan Genocide of 1994, traveling twice to Rwanda with case investigators. Provided briefing to former U.S. Ambassador W. Stuart Symington regarding investigative initiatives with the Rwandan government, and numerous training sessions regarding same. From 2010 to 2011, assigned to Domestic Operations from 2010 to 2011, responsible for task and executive reporting for national-level deliverables, simultaneously supporting the Office of the HSI Special Agent-in-Charge, New Orleans. Charged with training nationwide SAC offices on best practices regarding administration, budgets, and similar.
- 2006-2009: Assigned to the Foreign Corruption Investigations Group. Responsible for working with foreign law enforcement operatives to identify the movements, activities, and assets (often valued in the tens or hundreds of millions of dollars) of kleptocrats (despotic foreign leaders). Conducted numerous training sessions in this specialty to other domestic Federal and foreign law enforcement agencies. Subject area expert advisor to former U.S. Ambassadors Stephen Rapp (Special Rapporteur for Human Rights) and Frank E. Baxter (Uruguay).
- 2004-2006: Assigned to the Miami Joint Terrorism Task Force (JTTF). Worked closely with the Federal Bureau of Investigation (FBI) to identify trends and potential threats in the sphere of threats to U.S. persons and infrastructure. Participated in numerous surveillances of individuals whose actions were considered adverse to U.S. interests. Responsible for the arrest and initial prosecution of Luis Posada-Carrilles, who, until 2001, was considered one of the most wanted terrorists in the Western Hemisphere for the bombing of a Cubana Airlines flight off the coast of Barbados in 1976. Responsible for Posada-Carrilles' transportation to El Paso, Texas at great risk. Participated in his trial in El Paso in 2011.
- 2002-2004: Entered on duty as a Special Agent (U.S. Customs, later to become ICE/Homeland Security Investigations (HSI), Office of the Special Agent-in Charge (SAC), Miami, FL. Assigned to MIA passenger narcotics, and responsible for the investigation and prosecution of individuals intercepted with narcotics. Conducted surveillances and controlled deliveries of contraband to mid-level narcotics transportation agents. Conducted and participated in search and arrest warrant execution. Worked closely with Assistant U.S. Attorneys (AUSAs) to draft complaints and warrant applications, appear before grand juries, and prepare for and testify at trials.

- 1992-2002: Served as U.S. Customs Inspector at Miami International Airport (MIA), Florida from 1992 to 1995, responsible for the interdiction of narcotics and other contraband in the passenger and cargo environments. Assigned to the Bermuda Preclearance Facility (Bermuda International Airport) from 1995 to 2000, where duties included the advance processing of air passengers enroute to the U.S. and enforcing laws pertaining to undeclared merchandise and currency reporting requirements, as well as manning a local joint task force intelligence unit with the Bermuda Police Service to suppress narcotics and money laundering activity. Upon return to U.S.-based operations, from 1999 to 2002, assigned to Miami Seaport Contraband Enforcement Team, with responsibility for identifying, examining and interdicting large-scale cargo shipments, some of which contained large amounts of narcotics. Assisted in the development, testing, and implementation of the Applied Technology Program, which used novel modalities to rapidly and efficiently scan large cargo shipments in containers.
- 1990-1992: Served as a U.S. Immigration Inspector at John F. Kennedy International Airport, New York. Responsible for the admission of passengers with validly issued visas and similar documents. Identified individuals with counterfeit visas, who made false claims to United States citizenship and referred for adverse action. Adjudicated document files for those applying for Lawful Permanent Resident (LPR) status
