A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA, AMENDING RESOLUTION NO. 3884 TO INCREASE THE MAXIMUM AMOUNT NOT TO EXCEED FROM \$375,936, INCLUSIVE OF 2% OF THE COSTS FOR ALLOWANCE AND 10% OF THE EXPECTED COSTS FOR CONTINGENCIES TO ADD AN ADDITIONAL \$132,801.56 FOR A NEW TOTAL AMOUNT NOT TO EXCEED OF \$508,737.56; DIRECTING THE APPROPRIATE CITY OFFICIALS TO TAKE ANY AND ALL ACTION NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; DIRECTING THE CITY CLERK TO TRANSMIT A COPY OF THIS RESOLUTION TO THE FLORIDA DEPARTMENT OF TRANSPORTATION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on October 16, 2024, Resolution No. 3884 was adopted by the City Commission; and

WHEREAS, Resolution No. 3884 approved the execution of the Utility Work by Highway Contractor Agreement with the Florida Department of Transportation; and

WHEREAS, since the adoption of Resolution No. 3884, the costs associated with completion of this project have increased and therefore the Florida Department of Transportation is requesting an increase as more particularly described in **Exhibit “A;”** and

WHEREAS, the City’s professional staff has reviewed the request to amend Resolution No. 3884 and recommends approval thereof; and

WHEREAS, the City Commission finds that approving an amendment to Resolution 3884 is in the best interests of the health, safety, and welfare of the citizens and residents of the City of Pembroke Pines.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA THAT:

Section 1. The foregoing "WHEREAS" clauses are true and correct and hereby ratified and confirmed by the City Commission. All exhibits referenced herein and attached hereto are hereby incorporated herein.

Section 2. The City Commission of the City of Pembroke Pines, Florida, hereby approves an amendment to Resolution No. 3884 to increase the maximum amount not to exceed from \$375,936, inclusive of 2% of the costs for allowance and 10% of the expected costs for contingencies to add an additional \$132,801.56 for a total amount not to exceed of \$508,737.56, as more particularly described in **Exhibit "A;"** and

Section 3. The City Commission of the City of Pembroke Pines, Florida, hereby directs the City Clerk to transmit a copy of this resolution to the Florida Department of Transportation and the appropriate members of the City administration to take any and all other action necessary to effectuate the intent of this resolution.

Section 4. All Resolutions or parts of Resolutions in conflict herewith are hereby repealed to the extent of such conflict.
