**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA; FORMALLY APPROVING A DECORATIONS POLICY FOR DISPLAYS ON CITY PROPERTY; AUTHORIZING THE CITY MANAGER TO ADMINISTER AND ENFORCE THE DECORATIONS POLICY; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City Administration of the City of Pembroke Pines, by and through the City Manager, has traditionally selected the decorations displayed on City property throughout the year;

**WHEREAS**, in order to ensure that the City continues to speak for itself in selecting the decorations and displays on City property, the City Commission desires to formalize the City's long-standing practices for selecting such decorations and displays by authorizing the City Manager to administer and enforce the Decorations Policy attached hereto as **Exhibit "A"** (the "Decorations Policy"); and

**WHEREAS**, the City Commission of the City of Pembroke Pines finds that approval of the Decorations Policy is in the best interest of the health, safety, and welfare of the residents of the City of Pembroke Pines.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA, AS FOLLOWS:**

**Section 1.** The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

**Section 2.** The City Commission of the City of Pembroke Pines does hereby approve the Decorations Policy.

**Section 3.** The City Manager is hereby authorized to take all steps necessary to administer and enforce the Decorations Policy.
