AN ORDINANCE OF THE CITY OF PEMBROKE PINES, FLORIDA, APPROVING THE FRANCHISE AGREEMENT WITH BAZIN CORPORATION D/B/A A&B TOWING SERVICE, TO PROVIDE CITYWIDE TOWING SERVICES, WHICH IS ATTACHED HERETO AS EXHIBIT "A", AND INCORPORATED HEREIN; AUTHORIZING THE CITY MANAGER OF THE CITY OF PEMBROKE PINES TO EXECUTE THE AGREEMENT WITH BAZIN CORPORATION, ALL CONSISTENT WITH THE PROVISIONS OF SECTION 3.12 OF THE CHARTER OF THE CITY OF PEMBROKE PINES; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING FOR EFFECTIVE DATE.

WHEREAS, in accordance with the City's Procurement Code, the City advertised to bidders in its Request for Proposals PD-17-07 "Citywide Towing Services" (hereinafter "RFP") of the City's desire to seek proposals from qualified firms to provide emergency recovery, towing and storage services; and

WHEREAS, the City's Evaluation Committee met and evaluated the vendors based upon the information and references contained in the responsive proposals submitted and agreed to recommend Bazin Corporation, d/b/a A&B Towing Service (hereinafter "A&B"), for award of the contract to the City Commission; and

WHEREAS, in accordance with Section 3.12 of the City Charter, the City Commission desires to award the Franchise to provide citywide towing services to A&B; and

WHEREAS, the City and A&B. desire to enter into an agreement for towing services ("Agreement"), a copy of the Agreement is attached hereto as Exhibit "A", and incorporated herein by reference; and

designee, be and the same is hereby authorized and directed to do all things

necessary and expedient in order to effectuate the execution of the Agreement for

citywide towing services, including, but not limited, to the appropriating, budgeting,

and implementation of each of the terms, conditions, and provisions, thereof, so as to

best protect the health, safety, and welfare of the citizens and residents of Pembroke
