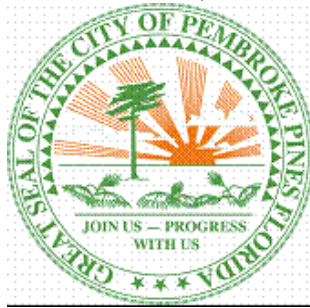

- 2. [26-2478](#) **MSC2026-0010, Plaza 67**, 6700 - 6740 Pines Boulevard, paint changes to the existing building, miscellaneous request. (Daniel) (District 4)

The following staff report was entered into the record:

**PROJECT DESCRIPTION / BACKGROUND:**

Gabriel Gomez, agent, is requesting approval of repainting the existing Plaza 67 building located on 6700-6740 Pines Boulevard. The site was built in the early 1960s. In 2005, site plan application SP2005-09 was approved, which established a uniform sign plan for the plaza.

**BUILDINGS / STRUCTURES:**

The applicant proposes the following modifications:

- o Main Body: SW 7074 Software
- o Accent: SW 7615 Sea Serpent
- o Monument Sign: SW 7615 Sea Serpent

No other site modifications are being proposed at this time. Building signs shall remain compliant with the current uniform sign plan.

**PROJECT DESCRIPTION / BACKGROUND:**

Steven Davis, agent, is requesting approval of a color change to the Boulevard Animal Hospital located at 6590 Pines Boulevard.

The existing building was constructed in the early 1970s. Signage for the site was last updated in 2014 through sign application SN2014-14.

The property owner was cited by the Code Compliance division for changes without approval. The following citations are on record with the Code Compliance division:

- Case #260301170 – 6590 Pines Boulevard – Paint color change without Planning and Zoning Board approval.

The following colors are proposed for the existing building and associated structures:

- Main body: SW 7667 (Zircon)
- Trim: SW 7669 (Summit Gray)
