AN ORDINANCE OF THE CITY OF PEMBROKE PINES, FLORIDA, APPROVING THE FRANCHISE AGREEMENT WITH PLANET T UNIFORMS, INC. TO PROVIDE SCHOOL UNIFORMS FOR THE PEMBROKE PINES CHARTER SCHOOLS WHICH IS ATTACHED HERETO AS EXHIBIT “A”, AND INCORPORATED HEREIN; AUTHORIZING THE CITY MANAGER OF THE CITY OF PEMBROKE PINES TO EXECUTE THE AGREEMENT WITH PLANET T UNIFORMS, INC., CONSISTENT WITH THE PROVISIONS OF SECTION 3.12 OF THE CHARTER OF THE CITY OF PEMBROKE PINES; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the City of Pembroke Pines (“City”) owns and operates Charter elementary, middle, and high schools with an approved dress code requiring school uniforms including a logo owned by the City; and

WHEREAS, in accordance with the City’s Procurement Code, the City advertised to bidders in its Request for Proposals of the City’s desire to seek proposals from qualified firms to provide school uniform services for the students of the City of Pembroke Pines Charter Schools; and

WHEREAS, the City’s Evaluation Committee met and evaluated the vendors based upon the information and references contained in the responsive proposals submitted and agreed to recommend PLANET T UNIFORMS, INC. for award of the contract to the City Commission; and

WHEREAS, in accordance with Section 3.12 of the City Charter, the City Commission desires to award the Franchise to provide school uniforms for the City’s Charter Schools to PLANET T UNIFORMS, INC.; and

WHEREAS, the City and PLANET T UNIFORMS, INC. desire to enter into a

School Uniform Agreement ("Agreement"), a copy of the Agreement, is attached hereto as Exhibit "A", and incorporated herein by reference; and

WHEREAS, the City Commission hereby determines this Agreement to be in the best interests of the health, safety and welfare of the citizens and residents of the City of Pembroke Pines.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA THAT:

SECTION 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Ordinance upon adoption hereof.

SECTION 2. The City Commission of the City of Pembroke Pines does hereby approve the Franchise Agreement to provide school uniforms for the City's Charter Schools with PLANET T UNIFORMS, INC., which is attached hereto as Exhibit "A" and incorporated herein.

SECTION 3. The City Manager of the City of Pembroke Pines is hereby authorized and directed, on behalf of the City of Pembroke Pines, to execute and to otherwise enter into the Agreement for school uniforms by and between the City of Pembroke Pines and PLANET T UNIFORMS, INC. for the exclusive right to provide school uniforms.

SECTION 4. The City Manager of the City of Pembroke Pines, or his designee, be and the same is hereby authorized and directed to do all things necessary and expedient in order to effectuate the execution of the Agreement for

school uniforms, including, but not limited, to the appropriating, budgeting, and implementation of each of the terms, conditions, and provisions, thereof, so as to best protect the health, safety, and welfare of the citizens and residents of Pembroke Pines, in accordance with the Charter and Code of Ordinances of the City of Pembroke Pines.

SECTION 5. All other terms, conditions, and provisions, shall be as set forth in the Agreement for school uniforms, which is attached hereto and made a specific part hereof.

SECTION 6. If any clause, section, or other part or application of this Ordinance shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part or application shall be considered as eliminated and so not affecting the remaining portions or applications remaining in full force and effect.

SECTION 7. All Ordinances or parts of Ordinances in conflict herewith be and the same are hereby repealed to the extent of such conflict.

SECTION 8. This Ordinance shall become effective immediately upon its passage and adoption.
