

<p>At approximately 0740hrs while on my morning post at Flanagan High School I was approached by (other#1) student Oliver Brenke. Oliver was noticeably upset and advised me that he was just approached by an unknown teacher near the cafeteria whom demanded he give him his "weed", then showed him some sort of badge from his wallet. Oliver advised me that he doesn't use marijuana or other drugs and he felt that the teacher or whomever it was, was out of line. Oliver described the teacher as a white male whom was wearing a lanyard around his neck and that he had a small badge in his wallet. Oliver was not familiar with the teacher as one of the regular staff, but thought he was a police officer based on the badge.</p> <p>After viewing the security cameras, it was determined that the faculty person in question was Commissioner Jay Schwartz. I notified Principal Fatout of the incident as well as PPPD Sgt. Walter.</p>

This investigative summary is being authored by Det. Danny Hidalgo/866. I am assigned to the Robbery and Homicide Unit. On 05/21/25, I was assigned to investigate a suspicious incident at Charles W. Flanagan High School at 12800 Taft St, Pembroke Pines, FL. My investigation is as follows.

A student named Oliver Brenke explained that he was in the hallway with some classmates when a middle-aged white male confronted them. The white male was walking past them when he stopped and asked, "Who has the weed? Where's the weed? Where's the weed?" Brenke said the male insisted the boys had weed and continued to tell them to give it to him. When the boys insisted they did not have any Marijuana, the male then started to lecture the boys about using profanities and getting a real job. He told them they would not get jobs or have good lives if they spoke that way. Brenke told the male that he already had a job as a lifeguard. The male then insisted Brenke tell him where he worked, saying, "You have to tell me where you work and how old you are." When Brenke refused to answer the questions and asked the male, "Who are you?" the male reached into his pocket and took out his wallet. The male opened the wallet and flashed a badge to Brenke and the boys. Brenke took this as the male was a law enforcement officer.

Brenke said he was under the impression that the male was a police officer even though he had never seen him before at the school. The male then put the wallet back in his pocket and questioned the boys. Brenke stated that the male was focused on him and continued to ask him about the alleged marijuana and profanities. Brenke said he felt very uncomfortable and was not free to leave because the male flashed a badge twice, implying he was a police officer. Brenke said he noticed the male had a lanyard around his neck with an ID that said teacher. I asked if the male had ever identified himself as a teacher, and he said, "No."

Brenke said the male flashed the badge twice during the interaction because they were not answering his questions. Eventually, the altercation ended, and the male walked away. Brenke found this very suspicious and reported it to SRO R. Williams, with whom he speaks frequently. Brenke asked if any undercover officers were in the school and explained what had just happened. Officer Williams then reviewed the school surveillance footage with security and found the altercation with the boys, which lasted approximately four minutes. They identified the male as Jay Schwartz, a vendor for Embry-Riddle Aeronautical University. Flanagan High School has an aviation program for students affiliated with this university program. They use flight simulators, which Schwartz helps out as a vendor. From what I gathered at the school, he is not an employee of Broward Schools, so it is unknown why he would have a teacher ID. I then interviewed [REDACTED], who was also present during the altercation. [REDACTED] gave the same account of the incident that Brenke gave me. [REDACTED] described that Schwartz was interrogating Brenke and insisting he answer his questions. At one point, Brenke told Schwartz, "I'm not used to this; I'm not from here," Schwartz replied, "Welcome to America."

[REDACTED] also saw the badge and assumed that Schwartz was a police officer. I asked if he felt he was being detained or not free to leave by Schwartz, and he said, "Yes." [REDACTED] gave an example of his friend trying to leave, and Schwartz said, "Where are you going?" [REDACTED] told his friend to stay and not leave to avoid further issues. [REDACTED] said he felt a police officer was interrogating them after he flashed them his badge. [REDACTED] also felt that Schwartz made a racist comment by telling them, "Welcome to

America" because they have a Caribbean accent.

I then spoke with the third witness, Dalex Ramos. Dalex gave the same information about the encounter with Schwartz. Dalex confirmed that Schwartz flashed a badge at them while questioning them. He also mentioned that Schwartz said, "Welcome to America" while addressing Brenke. My interview with Dalex was interrupted because his father wanted to be present during questioning.

I learned that the school's principal knew about this issue before my arrival. He was not there for me to speak with him when I was there. I talked to SRO R. Williams, H. Morgan, and W. Katz about this complaint and gathered the information they had. All interviews with the students were recorded using my BWC and have been uploaded to the case file. I did not speak to Schwartz then because I was told he had left the school grounds. I watched the surveillance footage and saw his interaction with the boys. It was later determined that FDLE would continue this investigation because Mr. Jay Schwartz is a commissioner with the City of Pembroke Pines. FDLE investigator Christopher Woehr has been assigned to this case.
