CITY MANAGER'S REPORT

Jonathan Bonilla and Nalini Sohit-Vazquez, on behalf of the City Manager's Office, presented the 2025 – 2026 Charter Elementary and Middle School Budgets. They covered the projected income and expenses for the Charter Elementary and Middle Schools in all areas, showing a balanced budget. Questions and observations from the board members and parents were answered by Mr. Bonilla. The board members approved the budget and set to send to City Commission for final approval

PRINCIPAL'S REPORT:

The Principals each presented board members with a certificate of appreciation for their service to the school and students. Principal Agustin presented the results of the board member election for East Campus Elementary for 2025-2026 and all of the members for 2025-2026 were announced and ratified by vote. The new board will be installed at the September 2, 2025 meeting. Mr. Chance stated the school grade should be issued by the state during July and gave a final wrap up for the year. He wished all a great summer.
