Consolidated Plan and Action Plan in order to receive CDBG funding; and

WHEREAS, the Consolidated Plan will be effective for a five-year time period; and

WHEREAS, the 2025-2029 Consolidated Plan and 2025-2026 Action Plan were noticed in compliance with the City's Citizen Participation Plan, as amended by the City Commission; and

**WHEREAS**, the City Commission finds that approving the 2025-2029 Consolidated Plan and 2025-2026 Action Plan is in the best interest of the health, safety, and welfare of the citizens and residents of the City.
