#### **OBJECTIVE:**

**SUMMARY:** I have thirty-four plus years of responsible and highly decorated experience in patrol, community policing and criminal investigations in Miami-Dade County's busiest and most violent neighborhoods as well as all other neighborhoods including county-wide operations and municipal policing while serving as the Assistant Chief of the SMPD. I am highly qualified and uniquely experienced from working at both the Miami-Dade Police Department (MDPD), which is one of the largest and most professional in the United States and using this experience at a municipal police department; the South Miami Police Department (SMPD) as the Assistant Chief of Police. The latter role allowed me to apply my vast experience to the smaller municipal police department especially in personnel matters. I have instilled the philosophy of active supervision through leadership ensuring all employees are held very accountable for their actions and performance.

I have personally trained and mentored for promotion, most of the current command staff members at the MDPD as well as several police chiefs throughout. Miami-Dade County. I ensured every assignment I commanded we valued diversity ensuring the units represented the community we policed.

I have consistently bridged the gap between police and all communities through trust-based relationships with both formal and informal community leaders enabling me to quell any potential problems before they arise. An example is my simultaneously being honored as an Urban League of Greater Miami Board Member Emeritus and South Florida Police Benevolent Association Life Member after serving many years on the Board of Directors of each entity. Currently a board member for the Embrace Girls Foundation and am a member of the law enforcement subcommittee for the Miami-Dade County Community Relations Board.

I possess unique and innovative enforcement related talents with a proven record of motivating subordinates and have also been commended for advanced community-oriented problem-solving policing capabilities. I have consistently reduced the crime rate while simultaneously reducing complaints, at every assignment at MDPD, since corporal, which is verified by matching my assignments to the Crime Information Warehouse computer base and Professional Compliance Reports at the MDPD. I also served at both the City of Miami Gardens and the Town of Palmetto Bay as the liaison while Miami-Dade Police provided police service to these two municipalities. I have a proven record of collaboration with all local law enforcement entities whether local, state or federal. ## Assistant Chief of Police:

As the Assistant Chief of Police, I am responsible for the overall management and administration of the Police Department and report directly to the Police Chief. I assist the Police Chief in planning, organizing and managing activities and operations in assigned functional areas within the Police Department ensuring departmental compliance with state and federal laws, city policies and procedures.

I directly supervise the activities of the Operations and Administration Bureaus. The Captains in command of these Bureaus report directly to me. I am also responsible for the Internal Affairs Unit and the Accreditation Unit. I also oversee the organization and assignment of work to police

personnel to ensure efficiency and effectiveness of operational procedures. I oversee the hiring process of new employees and the enforcement of departmental rules, policies and regulations.

The Police Chief has appointed me to be the liaison between the Police Department and other City departments as well as to the MDPD and our federal and state law enforcement partners.

## MIAMI-DADE POLICE DEPARTMENT: 1987 - 2018:

#### May 2017 to October 31, 2018:

**Division Chief, Special Investigations Division (SID):** I was responsible for command and control of all functions within the Division as the Chief of Detectives. The Division is comprised of the Government Services, Court Services, Economic Crimes, Homeland Security, Information Technology Services, Narcotics and Warrants Bureaus.

These entities are responsible for conducting sheriff's services such as court and building security, the service of process, injunctions, writs, warrants, and extraditions. SID conducts criminal investigations of major organized high-impact economic crimes, illicit narcotics importation, sale and distribution, drug related kidnappings, monitoring of career criminal and extremist/subversive activities. Other investigations include; arson, vice crimes, cargo theft and murder-for-hire in Miami-Dade County. Another function of SID is combating domestic terrorism, cyber-crimes and gathering and disseminating related intelligence as well as criminal intelligence through our nationally recognized fusion center known as the Southeast Florida Fusion Center.

Additional functions are as follows: the SID provides technology infrastructure support for the MDPD delivery of essential services and the Real-Time Crime (RTCC) Center offers the unique service of an aggregated search with immediate analysis of available data. The RTCC is responsible for the coordination and distribution of real-time information to police officers and investigators. The Police Operations Section of the Division is responsible for uniform police coverage and investigative service for Miami-Dade County's high-profile locations including, but not limited, to the following: Jackson Memorial Hospital Complex, Metrorail/Metro mover system, Fisher Island and the Stephen P. Clark Government Center.

#### July 2013 to May 2017:

Major, Warrants Bureau: I commanded the Warrants Bureau which is responsible for serving felony warrants in Miami-Dade County issued by the local criminal justice system and all jurisdictions nationwide. The Bureau is comprised of the Felony Apprehension Squads, the Extradition Unit, the Career Criminal Section, the Headquarters Security Section and the Operations/Administrative Unit. The Felony Apprehension Squads' primary responsibilities are to locate and apprehend individuals with outstanding felony warrants. Additional duties include the service of writs of bodily attachment, ex-parte orders, juvenile pick-up orders, grand jury indictments, and penal warrants. Squad members also assist in returning wanted subjects from other jurisdictions to Miami-Dade County for judicial proceedings. The Bureau participates in two ongoing multi-agency operations one with the U.S. Marshals Service: the Florida Caribbean Regional Fugitive Task Force and the other with the Federal Bureau of Investigations: South Florida Violent Crimes Fugitive Task Force. The task forces target fugitives wanted for federal and state warrants, as well as high impact violent crimes including, but not limited to homicide, felonious assaults, robbery, rape, sexual exploitation of children and drug related offenses. The Extradition Unit tracks and coordinates the arrest and return of felony subjects from around the world who are wanted in Miami-Dade County. The Operations/Administrative Unit provides support services such as warrants research and verification on a 24-hour basis for all Miami-Dade County warrants. The Career Criminal Section enforces all aspects of the Florida Career Offender Registration Act, such as verifying approximately 1,500 addresses per year of registered Career Criminals and serving arrest warrants on the Career Criminals. The Headquarters Security Section is responsible for security at Miami-Dade Police Department's Headquarters Complex; which includes the Midwest District, Property and Evidence Section, fueling station, and the main Headquarters building.

# July 2012 to 2013:

Major, Robbery Bureau: I commanded the Robbery Bureau, which investigates robbery offenses in unincorporated Miami-Dade County when requested in municipal jurisdictions; such as carjacking's, home invasion robberies, strong armed robberies, armed robberies, and domestic robberies for the purpose of apprehending offenders, preparing evidence and providing testimony so as to secure a conviction of the perpetrator. The Robbery Bureau utilizes a multi-faceted approach in its continual initiatives in reducing one of the most violent and inherently serial crimes known - robbery. To combat robberies and the violence associated with these crimes, the

Robbery Bureau uses investigative, intelligence, tactical and pro-active resources to encapsulate all aspects of thwarting robbery-related activity. The Robbery Bureau is comprised of four sections: Robbery Investigations Section (RIS), Robbery Intervention Detail (RID), Robbery Clearinghouse Section (RCS) and the Street Terror Offender Program (STOP). The STOP unit aggressively combats gun violence by aggressively targeting both individuals and groups involved in crimes involving firearms.

# November 2005 to July 2012:

Major, Narcotics Bureau: I commanded the Narcotics Bureau which conducts criminal investigations of all offenses relating to violations of narcotics and dangerous drug laws and money laundering. Narcotics investigations are conducted at three levels: interdiction, major investigations including manufacturing, and street level sales. The Narcotics Bureau is also charged with the responsibility of investigating narcotics related kidnapping for ransom. The Tactical Narcotics Team (TNT) is a comprehensive, five-phase program designed to reclaim areas of the County where cycles of drug dealing flourish, by arresting and vigorously prosecuting drug dealers, eliminating environmental conditions that often contribute to the high crime cycle, and educating members of the affected communities in safe methods of assisting the police in maintaining a drug-free low crime environment. The Narcotics Bureau broke several departmental records during my command in 2006, 2007 and 2008 such as overall arrests, drug arrests, drug labs dismantled, and firearms seized despite fewer detectives. Drastically reduced the overtime expenditures through accountability and daily supervision of all overtime expenditures.

November 2010 to present: The Gang and Organized Crime Units were added to the Narcotics Bureau under my command. The Organized Crime Section has the responsibility of investigating traditional organized crime activities such as: illegal lotteries, bookmaking, money laundering, illegal gaming machines, and prostitution. Additionally, the Section is also responsible for investigating human and sex trafficking, juvenile prostitution, murder for hire, and extortion investigations originating from organized crime groups or activities.

The Bureau's Street Gang Section is an investigative and information gathering entity which has the responsibility to assertively investigate street gangs and gather intelligence in order to combat their presence in the community and to function as the Department's Gang Information Clearinghouse. The Section is also the coordinating agency for the Multi-Agency Gang Task Force, which is organized under the auspices of the Miami-Dade County Association of Chiefs of Police.

# November 2008 through January 2009:

**Interim Chief, Special Investigations Division**: Responsible for the day to day managerial operations of the Warrants, Narcotics, Economic Crimes and Strategic and Specialized Investigations Bureaus.

# October 2006 through January 2007:

**Interim Chief, Special Investigations Division**: Responsible for the day to day managerial operations of the Warrants, Narcotics, Economic Crimes and Strategic and Specialized Investigations Bureaus.

# December 2003 until November 2005:

Major, Northside District: I commanded all activities of the Department's busiest district. I improved the operations, productivity and morale of the district through active supervision and leadership. I implemented a permanent, district-wide foot patrol for all officers, which has improved police-community relations. I created the Northside District's Command Staff Night Out that allows the community to meet the Command Staff in their neighborhood and allows for better communication and sharing of information between the Department and the citizens it serves. This initiative has been adopted throughout the Department and has improved police community relations.

#### July 2003 - December 2003:

Captain (Executive Officer), Carol City District and the City of Miami Gardens: I was tasked with managing the day-to-day operations of the District. I oversaw and facilitated the transition from a district station within the MDPD to to the "City of Miami Gardens," for contracted police services. I was tasked with getting overall crime there to decrease. My efforts resulted in a huge decrease in both robberies (largest in the department for 2003) and burglaries since assigned to the district. This was a factor in me being promoted to the rank of major and assignment to the Northside District.

# July 2002 - July 2003:

Commander (Captain), South Dade Neighborhood Policing Unit: This was the premier community-oriented, problem solving-policing entity at the MDPD. I was responsible for developing and managing operational plans, and the direction of a wide range of personnel and activities in response to crime trends and community crime concerns as well as community and departmental activities including the Agricultural Patrol Unit. Promoted and facilitated the formation of additional Crime Watch groups in the Cutler Ridge District. Assisted with the transition of the Town of Palmetto Bay as a contracted service via the Cutler Ridge District.

District Robbery Enforcement Coordinator, June 2002 to July 2003. Enforcement plan resulted in a 24% decrease in robberies during 2002 and the largest decrease in the department year to date during 2003.

# April 2002 - July 2002:

**Executive Officer (Captain), Cutler Ridge District**: In my capacity as a Police Captain, I was responsible for overseeing the day-to-day operations of the district station, which handles the most calls and covers the largest area in the department.

I monitored the scheduling, performance, and activities of more than 260 employees. I was accountable for an annual operating budget of more than 19 million dollars. Under my command we attained increased productivity and professionalism of the uniform platoons by holding them accountable for COMPSTAT concerns in their areas. I also oversaw the Enhanced Enforcement Details through its proper assignment and deployment as well as through accountability.

#### November 2001 - April 2002:

Lieutenant, Cutler Ridge District: Coordinator for the Grinchbusters detail that resulted in a 49% decrease in the overall crime rate in the targeted areas.

# March 2000 - November 2001:

Lieutenant, Narcotics Bureau: Responsibilities included initiating investigations involving the sale and possession of narcotics and dangerous drugs at the consumer level.

I oversaw the planning and execution of numerous high-risk search warrants and undercover drug stings. I significantly increased the seizures of monies for the "street squads," enabling the unit to purchase Nextel phones and laptop computers through this funding source.

# March 1998 - March 2000:

Lieutenant, Northside District: Responsibilities included commanding the Department's busiest and most violent shifts. Additional responsibilities included the supervision of the Priority Service Unit - a proactive narcotic and violent crime enforcement unit. Usually the on-duty and on-scene commander of all Crime Suppression Team and General Investigations Unit details during the afternoon shift. Also served as the District's Citizen's Advisory Committee's liaison to address crime concerns between meetings.

October 1998 — September 1999: Project Manager for the Northside District's Enhanced Enforcement Initiative. Responsibilities included the planning, coordinating and implementation of enforcement details targeting narcotic violators, drug gangs, robberies, prostitution, auto thefts and both residential and commercial burglaries. Also responsible for the EEI budget of \$250,000.

<u>June – September 1998</u>: Coordinator of the Northside District's Violent Crime Reduction Detail. Responsibilities included the planning, coordinating and on-scene command of all details that resulted in a 21 percent decrease in robberies. The Northside District's Crime Suppression Team was detached to my command during this period.
