MOTION TO APPROVE THE EXECUTION OF THE AGREEMENT WITH ARCHITECTS DESIGN GROUP IN THE AMOUNT OF \$87,520 FOR PHASE I OF THE CREATION OF A DESIGN CRITERIA PACKAGE FOR A NEW POLICE DEPARTMENT HQ (HEADQUARTERS) AS DESCRIBED IN RFQ # PD-17-01.

SUMMARY EXPLANATION AND BACKGROUND:

- 1. On August 2, 2017, the City Commission approved the findings and recommendation of the Evaluation Committee for RFQ # PD-17-01 "Design Criteria Professional to prepare the Design Criteria Package (DCP) for a new Police Department HQ" and awarded the project to Architects Design Group, Inc. and also directed the City Manager to negotiate a contract for services.
- 2. Architects Design Group, Inc. has met with City Administration and has negotiated a contract in the amount of \$87,520 for Phase I of the project. Phase I includes:

Phase I-A: Detailed Spatial Needs Assessment

Phase I-B: Site Analysis & Master Planning

Phase 1-C: Conceptual Design

- 3. After completion of Phase I of the project, the contractor will present the information to the City's Administration for additional direction and begin the negotiation of Phase II of this project, which will include the creation of the Design Criteria Package.
- 4. The time line for completion of Phase 1 of the project is 4-5 months or the end of March 2018.
- 5. The City Attorney's Office has reviewed and approved the contents of this contract.
- 6. Request Commission to approve the execution of the agreement with Architects Design Group in the amount of \$87,520 for Phase I of the creation of a Design Criteria Package for a new Police Department HQ (Headquarters) as described in RFQ # PD-17-01.

FINANCIAL IMPACT DETAIL:

- a) Initial Cost: \$87,520 for Phase I.
- **b)** Amount budgeted for this item in Account No: Once this item is approved, the budget for the Municipal Construction Fund will be increased by \$87,520.
- c) Source of funding for difference, if not fully budgeted: Not Applicable.
- **d) 5 year projection of the operational cost of the project**: TBD. After Phase 1 of the project is completed, the contractor will bring back a proposal for Phase II of the project, which will be negotiated with City Administration and brought back to the City Commission for approval.
