# Overview Proposed 2022-23 Budget Operating Funds

# Proposed 2022-23 Budget (Operating Funds)

- **General Fund** currently has a shortfall of \$5.3 million. Revenues could be adjusted in July based on July 1<sup>st</sup> taxable values as well as State revenue estimates.
- Road and Bridge Fund is funded primarily by gas tax proceeds. Estimates of these revenues will be published by the State in late July. This fund is short \$2.8 million.
- **Utility Fund** Utility rates based upon 4.01% CPI increase. The monthly increase is \$1.69 on 3,000 gallons. The budget has a shortfall of \$0.6 million.

# Items Funded in the Proposed 2022-23 Budget

# General Fund New City Positions

#### **Police Department**

- 1 Crime Scene Technician
- 2 Police Service Aide II (Code Compliance)

## Millage Rate

- The 2022-23 Budget is based on 5.6690 mills, which is the current operating millage rate. This rate is recommended for advertisement in the TRIM Notice and will be considered at the Commission Meeting this evening.
- 5.6690 mills is equivalent to approximately \$86.2 million in property taxes at 95% for early payment and value adjustment board changes.
- The current millage represents an increase in property tax revenues of \$6.1 million.
- The value of one mill is \$15,198,800.

### Millage Rate

- Due to the 8.82% increase in taxable value the proposed debt service millage rate is 0.3859 and the associated \$5.9 million revenue is budgeted in the Debt Service Fund.
- The aggregate proposed millage rate is 6.0549, which is 0.0300 mills below current year and represents the 7<sup>th</sup> consecutive year of decrease.
- The taxable value of homesteaded properties increased by 3% (save our homes cap) and their tax increase will be below 3% as a result of the decrease in the aggregate millage rate.

- The 2022-23 proposed residential rate is \$352.71, which is \$40.39 above the current year
- In 10 years since 2013-14, the residential rate has increased by only \$100.00.

## Cost of Visioning Items

• Increase Police Officers on patrol (0.0916 mills) \$1.4 mil

(Compensation & equipment for 6 officers - \$232K each)

• Traffic light installation on Palm Ave \$400 - \$500K and 7<sup>th</sup> Street (funded by developer)

• Installation of noise wall on Palm Avenue \$100 - \$110K from Pembroke Road to Pines Boulevard.

(1,270 linear feet wall 6' or 8' high)

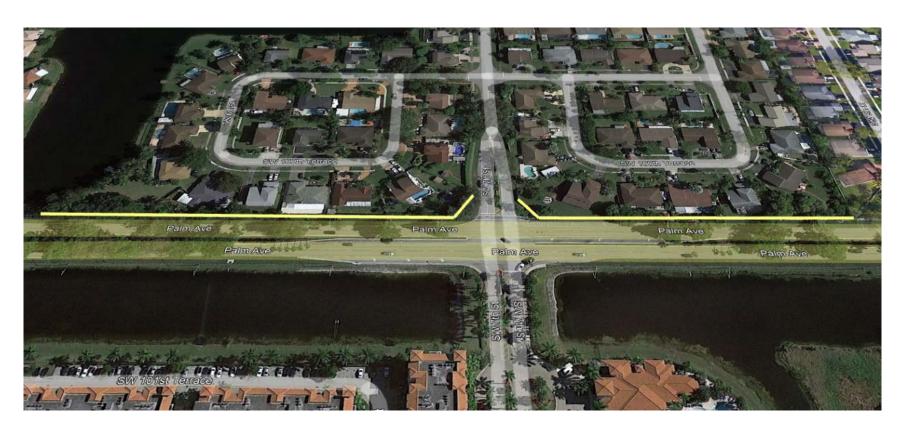
