INTRODUCTION

At the direction of the City Manager, a school traffic mitigation committee was created consisting of City staff from the Police Department, Engineering Division, Planning and Economic Development Department, Recreation and Cultural Arts Department as well as City Administration. The team was tasked with looking at solutions for managing traffic created by educational facilities within the City. While school related traffic is a regular issue, this year due to the COVID-19 pandemic, the City has seen a dramatic increase in personal vehicle traffic commuting children to and from schools in addition to a decrease in the use of school buses and shuttles.

EXECUTIVE SUMMARY

The City of Pembroke Pines is home to fifteen traditional public schools, five City Owned and Operated Charter School campuses and nine independently operated Charter Schools and private schools, all of which have a population of approximately 30,000 students and nearly 3,000 staff. The Committee intends to evaluate all educational facilities within the City, but this report will begin with an examination of the schools located south of Sheridan Street and west of 178th Avenue. Specifically; Chapel Trail Elementary, Silver Trail Middle School, West Broward High School, Pines Charter West, Somerset Academy North, Somerset Academy South and Franklin Academy South which have an enrollment of approximately 12,000 students. It is well known, that the education facilities within the City of Pembroke Pines are held high regard; which continues to make the City an attractive place for families. There are numerous challenges to traffic mitigation efforts including parental behavior, funding and the COVID-19 pandemic. It will take efforts from all stakeholders; parents, residents, school administrators and government officials to make a positive change to the traffic issues. The City and our stakeholders need to help educate our families as to our traffic regulations, school policies and busing opportunities available to them. Our residents also need to acknowledge that school is in session and their daily activities may be impacted by school related traffic and adjustments be made to lessen the impact.

On September 21, 2021 the City Commission held a town hall meeting to collect input from the community regarding the schools listed above. The well-attended event at the River of Grass Theater provided a forum for residents impacted by school related traffic to voice their concerns. A companion event was held at Pines Charter West campus on October 4, 2021 to specifically discuss issues occurring at the City's Charter school campus and the impact on the adjacent Encantada community. During both events, City staff presented areas where road improvements could occur, but much of the consensus was around trying to provide short term relief via better communication, stronger police enforcement and increased busing.

This initial report creates a profile for each of the schools listed above which identifies location, enrollment, amount of school staff and school operations. The profile also lists traffic concerns from the Police Department, City staff and the community at large. Finally the profile identifies short, medium and long term improvements to mitigate traffic at each school site. In addition, the City has engaged a traffic engineer as part of their continuing services contract to examine traffic concerns and provide recommendations.

Additional Citywide traffic mitigation options are also being examined including a review of City ordinances to improve the enforcement. The information contained in this report is being updated continuously as staff is able to meet with stakeholders and obtain more information. The committee appreciates the participation of our elected officials, residents and educational partners.

PINES CHARTER WEST CAMPUS

Pines Charter West is a City owned and operated K-8 charter school. The elementary school is located at 1680 SW 184th Avenue and the middle school is located at 18501 Pembroke Road. Both schools along with an Early Development Center share the campus located on the northwest corner of Pembroke Road and SW 184th Avenue directly adjacent to the Encantada neighborhood. The school has an enrollment of **1378** students, **152** staff and two school resource officers (SROs), Officers Scopa and Reynolds. Mr. Michael Castellanos serves as the Principal of the campus.

SHORT TERM IMPROVEMENTS

- City Staff met with Principal Castellanos and his team on September 29, 2021 to discuss traffic concerns, dismissal procedures and the future expansion of Pembroke Road.

Somerset Academy North Campus

Somerset Academy North Campus is a 6-12 Charter school operated by Academica, is located at 20805 Sheridan Street. The campus located on the northwest corner of Johnson Street and NW 208th Avenue and is part of the Chapel Trail warehouse area. The school is adjacent to the Chapel Trail neighborhood and specifically the Hidden Lake subdivision, the City operated storage lot and Rose Price Park. The school has an enrollment of **2882** students, **247** staff and one SRO, Bogoslavsky. Dr. Bernardo Montero serves as the Principal of the campus. In 2017, the City Commission approved a development order that included a voluntary enrollment cap at 2,900 students. The school previously operated as K-12, but migrated elementary students off north campus to their south campus located at Pines and 196th. The school also maintains a traffic operations plan, which is updated from time to time, that includes goals for busing 40% of their students.

SHORT TERM IMPROVEMENTS

- City Staff met with Principal Montero and his team on October 4, 2021 to discuss traffic concerns, dismissal procedures and the approved traffic operation plan. Staff has requested, in conjunction with their approved development order, that the school update their traffic operation plan to coincide with their current enrollment, hours and queuing concerns.
- School to ensure entire queuing line is being utilized daily.
- The City's Police Department has provided increased enforcement over the past few weeks. Officers
 were placed throughout the corridor to monitor speeding and cut through traffic along NW 4th
 Street.

- In addition the speed trailer was deployed to monitor speeding, which in addition to increases traffic volumes was a main complaint.
- Speed Trailer deployment to NW 19800 NW 4th St. for westbound (closing) and eastbound (away) traffic. The trailer recorded data from 09-16-2021 to 09-30-2021. The speed limit in the area is 25 mph. The following are the results from the survey:
 - The total vehicle count during the time frame above was 27,476.
 - 17,588 (64%) vehicles were under the speed limit.
 - 9,888 (36%) vehicles were over the speed limit.
 - The average speed calculated was 23 mph (2 mph below the speed limit).
 - The average speed over the limit was 30 mph. (Five (5) mph over the limit. Per FSS, vehicles traveling between 1-6 mph above the speed limit, can only be issued a warning.)
 - The 85th percentile speed, the speed in which 85% of the vehicles are traveling, was 30 mph.
 - The 10 mph pace count was 18-27 mph with 13,056 (48%) vehicles within that pace count.

Somerset Academy South Campus

Somerset Academy South Campus is a K to 5 Charter school, operated by Academica located at 20805 Sheridan Street. The campus located on the southwest corner of Pines Boulevard and SW 196th Avenue. The school is adjacent to the Speedway gas station and City owned Soccer Park. The school has an enrollment of **960** students, **80** staff and one SRO, Zorsky. Dr. Bernardo Montero serves as the Principal of the campus. In 2017 the Planning and Zoning Board approved a development order that included a voluntary enrollment cap at 1,000 students. The school serves as a shuttle stop for parents whose children attend the north campus.

Franklin Academy South Campus

Franklin Academy South Campus is a K to 8 Charter school, operated by Discovery Schools located at 18800 Pines Boulevard. Generally, the campus located on the south west corner of Pines Boulevard and SW 186th Avenue. The school has an enrollment of **1,360** students (926 - K-5 and 434 6-8) and **107** staff. Ms. Elena Diaz serves as the Principal of the campus. The campus provides bus service on a limited basis for students who live between two and six miles. They currently estimate that 435 students are actively using the bus service, but there is a total of 558 registered for the service.

SILVER TRAIL MIDDLE SCHOOL

Silver Trail Middle School is a traditional middle school operated by the School Board of Broward County. The 6-8 middle school is located at 18300 Sheridan Street and is north of the Silver Lakes neighborhood (Coconut Key) and east of Keystone Lake neighborhood. The school has an enrollment of **1361** students, **125** staff and one SRO, King. Mr. Steve Frazier serves as Principal.

The COVID-19 pandemic has presented several new traffic challenges at the inception of the 2021-2022 school year, due to a significant increase in student vehicle transport. The Pembroke Pines Police Department is responsible for ensuring the safety of all students and the community alike.

Prior to conducting stricter enforcement of Florida State Traffic Laws, this letter is intended to educate drivers on the types of actions that are contrary to state law, and for which the Pembroke Pines Police Department will commence strict enforcement. The Pembroke Pines Police Department expects everyone to obey the below stipulations, which are necessary to maintain the safe flow of traffic.

- Lining up, parking or stopping of any kind on the roadway, prior to 3:40 pm is strictly prohibited
- Do not block the intersections or any portion of the crosswalks in the area
- · Do not block driveways
- · Do not block entrances/exits to communities
- · Do not enter neighboring residential communities or businesses to park, awaiting the 3:40 pm dismissal time
- Do not park on the grass swales of neighboring communities. This practice eventually leads to property damage
- · Do not stop in the readway to pick up or drop off students

ANY VIOLATIONS OF FLORIDA STATE STATUTES WILL RESULT IN THE ISSUANCE OF TRAFFIC CITATIONS.

Please share this information with others designated to drop off or pick up students at Silver Trail Middle School.

- Request Traffic Sign and Signalization Improvements from Broward County via resolution to assist with enforcement. Requested improvements include the following:

- Signs NW 184th Avenue and Sheridan Street
 - No U-Turn during school zone times for north bound 184th turn lane to go west bound on Sheridan Street to keep cars from making a U-turn to go south bound on NW 184th Avenue and enter parent line as well as blocking intersection and crosswalk.
 - No turn on red during school hours for east bound Sheridan to go south bound on NW 184th Avenue, permits space to form in parent line for other directions of travel to fill in to reduce intersection blocking.
 - Do not block the intersection signs for west bound Sheridan traffic.
- Signs NW 184th Avenue at 2100 block (west side school entrance where parents vehicle line enters) No Stopping/ Standing/ parking signs in the n/b turn lane to enter the school and the center median turn lane going south bound on NW 184th Avenue to enter the school. These signs would provide an enforcement possibility for the parents that park there well before the school permits them in and causes a backup in the through lane of NW 184th Avenue.
- Signs NW 184 and NW 17th Street
 - Right turn prohibited during school hours to be evaluated as it might assist with keeping parents from lining up along NW 17th Street to cut in to the parent line, which causes the line that forms on NW 184th Avenue south of there to block the intersection to keep cars from NW 17th St from entering the line in front of them.
 - No stopping/ Standing/ Parking signs on the north side of NW 17th Street from NW 184th Avenue to NW 183rd Avenue to stop parents from using the road to drop off students to walk to school blocking traffic.

- City/ Broward County Funding Source TBD NW 184th Avenue Turn Lane
 - Proposal Lengthen the turn lane on east side of the road to increase queuing capacity into the campus.
- City Funding Source TBD Additional Turn Lanes
 - Proposal Add additional northbound right turn lane to NW 184th Avenue.
