**BPH 22-0632** FIRST PUBLIC HEARING ON ADOPTING A TENTATIVE BUDGET AND PROPOSED MILLAGE RATE FOR THE FISCAL YEAR 2022-23 FOR THE CITY OF PEMBROKE PINES, FLORIDA.

PURPOSE: RECOMPUTE AND PUBLICLY ANNOUNCE PROPOSED OPERATING MILLAGE RATE OF 5.6690, WHICH IS 9.06% ABOVE THE ROLLED-BACK MILLAGE RATE OF 5.1979, AND DEBT SERVICE MILLAGE RATE OF 0.3835, AS WELL AS AMEND AND ADOPT TENTATIVE BUDGET FOR GENERAL FUND, UTILITY FUND, AND ALL OTHER FUNDS OF THE CITY OF PEMBROKE PINES, AND INVITE THE PUBLIC TO SPEAK REGARDING THE PROPOSED MILLAGE AND BUDGET.

City Attorney Goren read the First Budget Public Hearing item into the record and provided an overview of the purpose of the hearing which was to adopt a tentative budget for the General Fund, Utility Fund, and each of the other Funds and to publicly announce the following rates for the 2022-2023 Fiscal Year:

Millage Rate: **5.6690** which is **9.06%** above the roll-back rate of 5.1979. Debt Service Millage Rate: **0.3835** 

City Manager Dodge provided a summary of the General Fund highlights which included the proposed millage rate of 5.6690 which would generate \$86.7 million dollars of tax revenue. The Debt Service Millage rage at 0.3835 would generate approximately \$5.9 million dollars for debt payments which would increase the property tax values by \$6.7 million dollars. The Proposed Ordinance requires 4/5 of the votes to be adopted.

Vice Mayor Schwartz inquired about the 12th slide of the PowerPoint presentation regarding the \$225 thousand dollars allocated for fencing at the East and West Disaster Debris Sites.

City Manager Dodge responded that the allocation would be a one-time expenditure. The East Site is located at the Howard C. Forman and the West Site located off Sterling Road. Mr. Dodge also responded to the question of reimbursement for the Federal Emergency Management Agency (FEMA) for hurricane debris disposals.
