Hi Mr. Dodge, I'm sending this message to recommend your approval of three emergency sewer main repairs and an associated budget amendment. The recent heavy rains have exposed three locations where the sewer

mains have defects/failures and are undermining the street/swale. These repairs are outside of the Jacobs contract because they are deeper than the four-foot limit in the contract.

Attached are quotes for the three locations (one of the quotes include two repairs) from Southern Underground Industries, piggy backing an annual sewer repair contract they have with the City of Fort Lauderdale. The total for these repairs is \$82,370.00.

Funding for these repairs would require a budget adjustment. I recommend the following:

For the future, I would like to take a piggy back contract to the Commission for annual sewer repairs at a not-to-exceed amount of, say, \$250,000 so that we can proceed with similar repairs without having to request emergency approval and obtain Commission ratification every time.
