The meeting of the Evaluation Committee ("Committee") for RFP AD 16 05 "Fleet Maintenance", was called to order by Gabriel Fernandez at 10:00 A.M. on Thursday, February 23, 2017, in the Conference Room of the Engineering Division, Public Services, 8300 South Palm Drive, Pembroke Pines, Florida, 33025.

Present to wit: Evaluation Committee: Members Carlos Bermudez, Steven Buckland, Lisa Chong, Riley Smith and Andrew Teixeira. Also Present: Gabriel Fernandez, Assistant Purchasing Manager; Assistant City Attorney David Tolces; and Board Secretary Katherine Borgstrom.

Gabriel Fernandez, Assistant Purchasing Manager, presented the purpose of the meeting, which is for the Committee to publicly review and rank proposals. The committee will be asked to consider each vendor according to the criteria provided in their package and score the proposals according to the percentage allotment afforded to each criteria. The committee will finalize their scores. The City Clerk will tally each evaluator's score card and rank the score cards according to the total scores. The end result will be a final ranking by each member of all vendors listed and no ties on the individual evaluators score cards. The rankings will be read aloud and the Evaluation Committee will then be asked to recommend to the City Commission a list of vendors to be approved for Fleet Maintenance.

A motion by Member Chong, seconded by Member Buckland, to nominate Member Smith to serve as Chairman, passed unanimously.

Chairman Smith called for questions or discussion. Members discussed deeming vendors unresponsive based on non-inclusion of a bid bond and why one vendor was not given local vendor preference points on the score sheet, to which Mr. Fernandez responded they did not include their Pembroke Pines local business tax receipt. Members discussed past performance of vendors who had submitted proposals and experience of vendors with fleet maintenance.

A motion by Member Buckland, seconded by Member Bermudez, to deem Adventure Tires LLC and Pines Ford Lincoln (Malo Automotive Group) as non-responsive due to non-inclusion of a bid bond failed. Vote was Member Buckland yea and Members Bermudez, Chong, Smith, and Teixeira nay.

There being no further questions, the Committee begin scoring the remaining vendors.

The Secretary entered the scoring and finalized the ranking. Gabriel Fernandez read the results of the scoring as:
