NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY
OF PEMBROKE PINES, FLORIDA, THAT:

Section 1. Any financial institution authorized by law and by the Charter of the City of Pembroke Pines, in accordance therewith, are hereby designated as the official depositories of the City of Pembroke Pines, Florida, and that any and all funds therein contained shall be subject to withdrawal upon checks, notes, drafts, bills of exchange, acceptances, undertakings, or other orders for the payment of money by said City, signed by any two (2) of the following City Officials, to wit:

The City Manager

The City Clerk

Section 2. Designated financial institutions shall be and they are hereby authorized and requested to accept, honor, and pay without further inquiry, and until the delivery to them of written notice of the revocation of the authority hereby granted, all checks, transactions on investments, and other orders for the payment or withdrawal of money deposited with said financial institutions in the name of the City, including checks or other orders for money shall be signed or endorsed in the name of the City by two (2) officers hereinbefore named.

Section 3. Any and all endorsements made for or on behalf of the City upon checks, drafts, notes, and instruments for deposits to the account of the City may be written or stamped endorsement of the City without any designation of the person making such endorsements.

Section 4. With the signatures of at least two (2) of the officers designated in Section 1 hereof, these officers are herewith authorized and directed to open new accounts in the aforementioned banks and associations in the name of and to the accounts of the City of Pembroke Pines, Florida, and with the same authority as set forth herein including the authority to open new accounts in banks and institutions not specifically referred to herein, but otherwise qualified and authorized as provided by law.

Section 5. The authority of the officers named in Section 1 hereto to sign checks, withdrawals, drafts or other order for payment upon one or more of

the accounts of the City may be restricted from time to time. The aforesaid banks or associations shall not be bound by such restrictions unless and until they have actually received a written certificate made by the City Clerk notifying them of such restrictions.
