Hello Iris,

After the great shooting tragedies at Vegas and Texas, I started thinking, just like many other parents I thought, just how safe are my twins at their daycare after school program and my baby girl during the day. So I met with an offduty police officer to find out just how good the security features were in slowing down a crazed gunman from walking in and start shooting everyone. To my amazement, there were two obvious gaps. Even though "some" daycares have locked doors where the children are, most don't have locked doors to the main entrance office during the day (secured by a remote buzzard to allow people in). If someone came in waving or shooting off a gun, there is no panic button (under desk for example or somewhere else) to immediately contact the police - no questions asked, unless that person has the courage to pick up the phone, dial 911 and explain what's going on, in the middle of the mayhem. These are both items that do not surpass more than \$1,000 to implement. These were such great ideas I suggested, that KINDERCARE (pretty big) are implementing these securities features at my kid's daycare while you read this email. I have introduced these same ideas to the Broward County School District regarding their single point entries which still remain unlocked with no buzzard and no one has a panic button. A great number of people at the District are looking into implementing these two ideas into their recently approved security budget.

I would like to find out if it's possible for this to be enforced within 90 days (not an option) by the city when it
