AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA, ESTABLISHING THE OPERATING MILLAGE RATE OF 5.7100 OR \$5.7100 PER THOUSAND DOLLARS OF TAXABLE ASSESSED PROPERTY VALUE, WHICH IS 6.98% ABOVE THE ROLLED-BACK RATE OF 5.3374, FOR THE CITY OF PEMBROKE PINES, FLORIDA, PURSUANT TO THE 2018-2019 CITY BUDGET. ACCORDANCE WITH CHAPTER 200, FLORIDA STATUTES; AND ESTABLISHING THE DEBT SERVICE MILLAGE RATE OF 0.4683 FOR DEBT SERVICE ON THE GENERAL OBLIGATION BONDS APPROVED BY THE ELECTORATE; **PROVIDING FOR** CONFLICTS; **PROVIDING** SEVERABILITY: PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, a tentative budget has been prepared estimating expenses and revenues of the City of Pembroke Pines, Florida, for the ensuing year, with detailed information, including revenues to be derived from sources other than ad valorem levy, and the administrative staff of the City has made recommendations as to the amount necessary to be appropriated for the ensuing year; and

**WHEREAS**, pursuant to Chapter 200, Florida Statutes, a method is prescribed for fixing the millage for the purpose of establishing the basis for the collection of said funds; and

WHEREAS, pursuant to the referendum approved by the voters of the City in the March 2005 Special Election authorizing the issuance of General Obligation bonds in an amount not to exceed \$100,000,000, the City will be levying a debt millage equal to 0.4683 towards the payment of principal, interest (00247718.1 1956-7601851)

and other related fees of those bonds issued by the City in 2005, 2007 and 2015; and

WHEREAS, the City of Pembroke Pines, Florida, pursuant to State Statute, now desires to adopt the City's operating millage at 5.7100;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION
OF THE CITY OF PEMBROKE PINES, FLORIDA, THAT:

**Section 1**. The foregoing "Whereas" clauses are hereby incorporated herein.

<u>Section 2</u>. The requisite advertisements, public hearings and ordinances necessary to establish the City millage shall be conducted and prepared.

**Section 3.** Pursuant to Chapter 200, Florida Statutes, a Public Hearing shall be held on the 4<sup>th</sup> day of September, 2018, and a second Public Hearing shall be held on the 17<sup>th</sup> day of September, 2018.

**Section 4.** The City Clerk is directed to prepare and publish the necessary advertisements for the Public Hearings.

<u>Section 5</u>. After the conduct of the Public Hearings, and the adherence to all other requirements pursuant to Chapter 200, Florida Statutes, the City's debt service millage shall be 0.4683.

Section 6. The City's operating millage shall be set at 5.7100, which is

greater than the rolled-back rate of 5.3374 mills by 6.98%.

The City's aggregate millage is 6.1783, which consists of Section 7.

an operating millage of 5.7100 and a debt service millage of 0.4683.

Section 8. A certified copy of this ordinance shall be furnished to the

Broward County Property Appraiser so that said revenues may be collected and

furnished to the City of Pembroke Pines.

Section 9. If any clause, section, or other part or application of this

Ordinance shall be held by any court of competent jurisdiction to be

unconstitutional or invalid, such unconstitutional or invalid part or application

shall be considered as eliminated and so not affecting the validity of the

remaining portions or applications remaining in full force or effect.

**Section 10.** All Ordinances or parts of Ordinances, Resolutions or parts

of Resolutions in conflict herewith are hereby repealed to the extent of such

conflict.

Section 11. This ordinance shall become effective immediately upon its

passage and adoption.
