## RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA, IMPLEMENTING ORDINANCE NO. 1914 BY ADDING "NO THRU-TRUCK" SIGNS ON NORTHWEST 208<sup>TH</sup> AVENUE FROM PINES BOULEVARD TO JOHNSON STREET; AUTHORIZING ALL NECESSARY ACTIONS TO IMPLEMENT THE INTENT OF THIS RESOLUTION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Commission of the City of Pembroke Pines, Florida finds that the use of Trucks on NW 208<sup>th</sup> Avenue from Pines Boulevard to Johnson Street can cause hazardous conditions for other vehicles, drivers and pedestrians; and

WHEREAS, Section 71.05 of the City Code, entitled "Restrictions on Truck Use of Streets" establishes the regulation and prohibition of thru-truck traffic on certain streets and roads within the City; and,

WHEREAS, Section 71.05(C) of the City Code, entitled "Establishment of Zones"

provides authorization to the City Commission to designate to specific right-of-ways on which thru-truck traffic shall be prohibited; and,

WHEREAS, the City Commission desires to install "No Thru-Truck" signs on NW 208<sup>th</sup> Avenue from Pines Boulevard to Johnson Street; and,

WHEREAS, the City Commission deems it to be in the best interests of the health, safety, and welfare of the citizens and residents of the City to install "No Thru-Truck" signs on NW 208<sup>th</sup> Avenue from Pines Boulevard to Johnson Street.

NOW THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA, THAT:

<u>Section 1.</u> The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

**Section 2.** That the City Commission of the City of Pembroke Pines, Florida, hereby approves funding for the cost of the installation and maintenance of "No Thru-Truck" signs on NW 208<sup>th</sup> Avenue from Pines Boulevard to Johnson Street.

**Section 4.** The City authorizes the City Manager and his/her designees to take all action necessary to implement the intent of this Resolution.

**Section 5.** All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

<u>Section 6.</u> If any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or application, it shall not affect the validity of the remaining portions or applications of this Resolution.

**Section 7.** This Resolution shall become effective immediately upon its passage and adoption.
