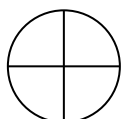

Apply finish coat of Macropoxy 5500 White, 6 to 10 mils DFT

Exterior steel surfaces not requiring removal of existing coatings

Pressure clean @3500 PSI to remove all Dirt, Mildew, or any foreign items that could contaminate exterior surfaces

Spot grind any rust location by mechanical means

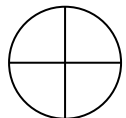

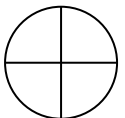

All payments for goods and services rendered are due upon receipt of invoice(s). Any invoice not paid within thirty (30) days shall be subject to interest at 1.25% per month. Delinquent accounts, those not paid in forty-five (45) days, that are sent to legal collections will require the Client to pay legal, attorney and paralegal fees in addition to amount due and interest. In addition, legal disputes under this contract of work will be filed with the Broward County Court System. Prevailing party of any litigation will be eligible to recoup court costs, mediation fees, legal & paralegal fees and any other fees related to the claim.
