**A RESOLUTION OF THE CITY OF PEMBROKE PINES, FLORIDA AMENDING THE BUDGET FOR THE CITY OF PEMBROKE PINES\FLORIDA STATE UNIVERSITY CHARTER ELEMENTARY SCHOOL FOR THE CHARTER SCHOOL FISCAL YEAR JULY 1, 2018 THROUGH JUNE 30, 2019; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Fiscal Year for the City of Pembroke Pines \Florida State University Charter Elementary School ("Charter School"), commenced July 1, 2018 and concluded June 30, 2019; and

**WHEREAS**, Resolution No. 2018-R-19 was adopted by the City Commission on June 20, 2018 providing the Budget for the revenues and expenditures of the Charter School for the Fiscal Year of the Charter School sponsored by Florida State University ("FSU"); and

**WHEREAS**, due to changes in the revenue and expenditures in the Charter School budget throughout the fiscal year it is necessary to amend the 2018-2019 Fiscal Year Charter School Budget;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA THAT:**

**SECTION 1.** The foregoing "WHEREAS" clauses are hereby ratified and confirmed as true and correct and by this reference incorporated herein.

**SECTION 2.** The Charter School 2018-2019 Fiscal Year Budget is hereby amended pursuant to **Exhibit "A,"** which is attached hereto and expressly made a part hereof.

**SECTION 3.** The funds appropriated for the expenditures designated in the Budget include state-shared revenues received from the State of Florida, federal and state grants, as well as contributions received from various benefactors.

**SECTION 5.** If any clause, section, other part, or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or application, it shall not affect the validity of the remaining portions or applications of this Resolution.

**SECTION 6.** This Resolution shall become effective immediately upon its passage and adoption.
