#### PRESENTATION ITEM:

**19-0741** WS-1: BUDGET PRESENTATION REVIEW WORKSHOP - PROPOSED BUDGET 2019-2020.

City Manager Dodge provided an overview of the budget presentation for the Proposed Budget 2019-2020 fiscal year.

City Manager Dodge stated each of the Specialty Funds were balanced for the year, and referred to Proposed Resolution 2019-R-22 on the Fire Assessment and Item 48 coming up on the June 19, 2019 Commission Meeting Agenda. He said adoption of the resolution and passage of the item would provide the mechanism to advertise the Fire Assessment rate and the millage rate for the TRIM notice, to be published by the Broward County Property Appraiser in August 2019.

If the proposed Operating Millage rate of 5.6736 remains the same from the 2018-2019 fiscal year with a Debt Service rate of 0.4464, this would generate an additional \$4.5 million dollars of revenue for the 2019-2020 fiscal year due to an increase in the taxable values. The proposed Residential Fire Assessment rate of \$282.38, an increase of \$10.63 over last year's rate would generate \$23.5 million dollars of revenue. The City of Pembroke Pines continues to maintain one of the lowest rates in the County.

City Manager Dodge reviewed the following topics that were included in the budget:

The annual impact on the Median Residential Property

Staffing needs Proposed City Projects Review of the Road and Bridge fund The Utility fund (Capital Improvement Plans) was briefly reviewed, but would be discussed in more detail at a future workshop.

Mr. Dodge also reviewed the following projects that are not included in the budget and proposed options in order to complete the projects:

New Police Department Head Quarters

Civic Center and parking garages

Club 19 facility improvements

911 Memorial Park

License plate readers at gateways

Road expansion projects
