PROPOSED ORDINANCE 2019-15 IS AN ORDINANCE OF THE CITY OF PEMBROKE PINES, FLORIDA, AMENDING CHAPTER 32 OF THE CITY'S CODE OF ORDINANCES, ENTITLED "DEPARTMENTS, BOARDS, AND COMMISSIONS;" BY AMENDING THE "DIVERSITY AND HERITAGE ADVISORY BOARD" TO REVISE THE BOARD COMPOSITION; PROVIDING FOR CODIFICATION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

PRIOR TO THE VOTE BEING TAKEN:

City Attorney Goren read Proposed Ordinance 2019-15 into the record, by title.

No members of the public spoke on the item.

Vice Mayor Schwartz announced Ms. Michelle Acuna and Ms. Dawn Prospect, as the District 2 alternate members of the Heritage and Diversity Advisory Board.

Commissioner Good announced his District 1 appointments, Ms. Shauna Hicks-Lee as a regular member and Mr. Ram Tewari as an alternate member to the Heritage and Diversity Advisory Board.

REPORTS OF LEAGUE REPRESENTATIVES:

Commissioner Good spoke about Broward County's proposed ordinance regarding installing sewer systems. He expressed concern that this county ordinance could put the burden of enforcement on municipalities. The City would be required to enforce connection to the County sewer system. City residents might not be able to afford to connect. He said the Pembroke Pines City Commission should be able to address the language and intent of the proposed Broward County ordinance.

Commissioner Good made a motion, seconded by Commissioner Siple, to direct the City Manager to look into the county's release of the franchise area to the City, and draft a letter for the Mayor to sign. Motion carried by the following vote:

REPORTS OF THE CITY MANAGER AND CITY ATTORNEY

City Attorney Goren spoke on the pending DACA case heading from the 9th Circuit Court to the Supreme Court. The United States Conference of Mayors asked mayors of a number of jurisdictions, including Los Angeles, New York, Atlanta, Chicago, and entities such as National League of Cities and the United States Conference of Mayors, to sign on to the Amicus brief. The City of Los Angeles drafted an Amicus brief on the Deferred Action for Childhood Arrivals (DACA) case to go before the Supreme Court. Mayor Ortis cannot sign on to the Amicus Brief without the concurrence of the Pembroke Pines City Commission.

A motion was made by Vice Mayor Schwartz, seconded by Commissioner Siple, to approve that Mayor Ortis represents the City of Pembroke Pines in all legal capacities with the United States Conference of Mayors, under the direction of the City Attorney, to sign on to the Amicus brief in support of DACA. REPORTS OF THE CITY MANAGER AND CITY ATTORNEY

City Attorney Goren spoke on a pending proposed constitutional amendment in the State of Florida, an Amicus brief in support of an assault weapons ban. The State Attorney General opposed the ban and may not allow the item to appear on the ballot.

Mayor Dan Stermer from City of Weston prepared a form resolution which the City Attorney would submit to the City of Pembroke Pines at the next Commission meeting which would authorize the City of Pembroke Pines to join in the filing of an Amicus brief to support that item to grant constitutional access and voting rights to Florida Citizens on this constitutional amendment. The brief is filed by Weiss Serota, et al, to join with other cities in Broward County, and may incur minimal costs, but those costs would be less than the amount incurred by cities filing separately.

A motion was made by Commissioner Siple, seconded by Vice Mayor Schwartz, to approve that the City Attorney bring back a proposed resolution at the next Commission meeting. The motion carried by the following vote:

NEW BUSINESS:

Vice Mayor Schwartz brought up under NEW BUSINESS the matter of the City of Pembroke Pines Charter Schools allocations.

City Manager Dodge spoke about the proposed bill of the Broward Delegation to support municipally owned and operated charter schools, and comparisons of revenue sources afforded to the City run charter schools versus the district schools. Comparisons showed a difference in revenue of almost \$7,000,000 a year. This amount of resource could be significant to the operation of the Pembroke Pines charter schools, and could help with increases in teacher salaries and reduction of debt.

Mr. Dodge said the proposed bill was drafted and submitted but then withdrawn at the last minute. He said he would pursue the issue with the Broward Delegation and inform the Commission of further updates.

A motion was made by Vice Mayor Schwartz, seconded by Commissioner Siple, to approve giving direction to the City Manager to request that Broward Delegation Chair Jones sponsor the bill. The motion carried by the following vote:

Vice Mayor Schwartz inquired about the national "If You See Something, Say Something" Awareness Day with the City Attorney.

City Attorney Goren responded to the Commission about the legal ruling on the matter and provided scenarios of what the process would be if there was a threat at City Center.

OLD BUSINESS:

Commissioner Siple brought up the Honor Flight South Florida Organization that raises money to take veterans to Washington, D.C. The Commission agreed by Consensus that the City participate in the fundraising efforts for the program.

Mayor Ortis mentioned Pembroke Pines Police Sergeant John Baker who was seriously injured in a traffic accident on August 11, 2019.

Sergeant Baker is still hospitalized. He was transferred to Atlanta for rehabilitation.
