COMMISSION WORKSHOP/SPECIAL MEETING ITEM:

WS-1 19-1100 WORKSHOP ITEM 1: CITY OF PEMBROKE PINES COMMISSION WORKSHOP DISCUSSION ON THE USE OF CITY FACILITIES.

WORKSHOP BIOGGOROW ON THE GOL OF OUT TAKELINES.

Mayor Ortis called the workshop to order and introduced City Manager Dodge.

City Manager Dodge provided an overview of the workshop. He said the purpose of the workshop was to discuss implementing a policy

regarding the use of the City facilities. There would be a policy to govern the leasing of city facilities.

Vice Mayor Schwartz made a point of clarification to include other City facilities: Southwest Focal Point Senior Center, Recreation Center, Spring Valley and Towngate facilities, as well as the Pembroke Pines Charter Schools.

Mr. Dodge confirmed that the aforementioned City facilities would also be included along with City Center.

Commissioner Castillo spoke on the City's proprietary responsibilities. He said that each city facility had different statutes pertaining to types of buildings, i.e. schools, and made reference to the City Attorney's legal memorandum dated September 4, 2019.

City Attorney Goren referenced a legal memorandum to the Commission dated September 4, 2019 as a supplement to previous legal memoranda dated August 27, 2018 and May 9, 2019, regarding the uses of City facilities and specifically City Center and gun shows. The legal memorandum of September 4, 2019 provided options to the Commission for consideration pertaining to uses of City facilities. The intended purposes in which the City Center would be used, including retail events as referenced from the 09-04-19 City Attorney memorandum on page 2 section 1:

"...prohibiting the rental of the City Center for all retail events, or events where a retail component exceeds a certain percentage threshold and section 4 to defer approval of any future gun show events while waiting for further judicial relief matters currently pending in the appellate courts."

The City Attorney responded to questions from the Commission pertaining to the options listed in the memorandum:

- 1) Prohibit the rental of the City Center for all retail events, or events where a retail component exceeds a certain percentage threshold.
- 2) Make the determination that the City, in its proprietary capacity as the owner and operator of a venue, will no longer permit gun shows to be held at the City Center.
- 3) Seek additional relief through the Legislature, consistent with the action taken by the City Commission at its August 21, 2019 regular meeting.

4) Defer approving any future applications for gun show events while waiting for further judicial relief on matters currently pending in the appellate courts.

City Attorney Goren spoke about the pending litigation against the State of Florida regarding Chapter 790.33 of the Florida Statutes regarding field of regulation of firearms and ammunition preempted, in which the City was a co-plaintiff along with Coral Springs, Coconut Creek, and Wilton Manors. The case was appealed and that the statute would remain intact as is.

City Attorney Goren concluded by speaking about the meaning of the word "draconian"--meaning excessively harsh, severe, extreme, and iron-fisted as it pertained to F.S. 790.33 and its prohibitions and penalties for local gun control regulations. Mr. Goren said all the information he provided to the Commission was to protect the best interests of the City concerning the matter.

The following items were discussed by the Commission:

- Each facility being governed by different Florida State Statues dependent on the facility type and what the City's proprietary responsibilities would be.
- Options listed in the Legal Memorandum of September 4, 2019.
- Determining a reasonable percentage threshold for retail shows before the event becomes unauthorized.

Steve Clark, General Manager of SMG, responded to the questions of the Commission regarding event contracts.
