ADULT CIVIL CITATION (ACC) PROGRAM TIMELINE OF EVENTS AND PROVIDER SELECTION

Timeline:

- Feb 2017. City Commission adopts ACC City Ordinance on 2/15/2017.
- March April 2017. The Police Department drafts a Statement of Work for a proposed RFQ to find a not-for-profit provider, based off the *then* Leon County/Tallahassee ACC Model plus with consultation with PPPD staff. Key requirements of the SOW state:
 - Program must be completed within 1-90 days
 - o Provider cannot charge more than \$350.00 for the educational/counseling services
 - Provider <u>must</u> provide to all offenders: a drug screen and general assessment (gainq, addiction severity index, or similar tool) to identify potential life problems.
- ➤ June 2017. City Commission approves the posting of an RFQ solicitation on 6/7/2017.
 - \circ RFQ solicitation is posted, and open for 30 days, between (6/20/17 7/18/2017)
 - o No responses/proposals are received
- August October 2017. The police department reaches out to three (3) local providers to see if they could meet the requirements outlined in the original RFQ. They include: Justice for Life; South Florida Therapeutic Solutions; and Chrysalis Health
 - South Florida Therapeutic Solutions appears to be the most responsive in their ability to meet the requirements in the RFQ. Their references include: Childnet, Fort Lauderdale Diversion Program, 17th Judicial Circuit misdemeanor/felony drug court, BSO Broward County Substance Advisory Board.
 - Formal recommendation memo is sent to up the chain to procurement in November 2017.
- ➤ <u>December 2017</u>. City Commission approves the selection of South Florida Therapeutic Solutions, via a Letter of Understanding (LoU) on 12/20/2017. The LoU contains the same requirements outlined in the original RFQ.
- > <u>January September 2018</u>. Remaining program components are put together:
 - Creation of the agency's ACC policy
 - Creation of the ACC citation & computerized tracking logs to monitor offender statuses (citations issued, missed opportunities, offenders who pass or fail, etc)

ADULT CIVIL CITATION (ACC) PROGRAM TIMELINE OF EVENTS AND PROVIDER SELECTION

- Creation of internal workflows between officers, the records unit, powerDMS (policy software), and training, finance and collecting the civil penalty
- o It is decided that SFTS will handle restitution on behalf of the City, the City Commission approves 1st amendment to the SFTS LoU on 8/1/2018
- > October 2018. Program goes live 10/5/2018.
- March 2019. Both the police department and SFTS agree for a 2nd amendment, to allow SFTS to monitor offenders that are receiving treatment at another facility *if they are receiving* a *higher level of care*. City Commission approves 2nd amendment to SFTS LoU on 5/15/2019.
 - Around this time, the department becomes aware of the language discrepancy in the Ordinance (not-for-profit) and begins the formal process to amend the ordinance after consultation with legal.

5/15/2019 -	Commission approves the 2 nd amendment to the LoU

 - a. Broward County's program has been opted into by BSO and Fort Lauderdale. The county has been providing ongoing rollcall training to both agencies, has been slow to roll out.
