### SUMMARY EXPLANATION AND BACKGROUND:

### (A) PSPW-19-07 "Construction of Raintree Park"

The City of Pembroke Pines is seeking bids from qualified firms for the construction of Raintree Park.

### (B) PSUT-19-03 "Water Treatment Facility Improvements"

The City of Pembroke Pines is seeking bids from qualified firms to make necessary improvements at the City's Wastewater Treatment plant.

### (C) PSUT-19-04 "Metal Overhang for Wastewater Treatment Plant BCR Building"

The City of Pembroke Pines is seeking bids from qualified firms to construct a metal overhang at the WWTP BCR Building. Such overhang is necessary for the proper handling of the solids discharge, protecting the material from the elements as they are loaded into the transportation vehicle for final destination.

### (D) PSEN-19-05 "Senior Center Parking Lot Improvements"

The City of Pembroke Pines is seeking bids from qualified firms to make critical modifications and improvements to the parking lot at the S.W. Focal Point Senior Center located at 301 N.W. 103rd Avenue. The purpose of these modifications is to provide additional parking spaces in the parking lot, and to construct additional offsite parking spaces within NW 103rd Avenue between existing access driveways along the street frontage of the senior center campus.

# (E) TS-19-02 "Chromebooks, Licenses, and Mobile Carts for Pembroke Pines Charter Schools"

The City of Pembroke Pines is seeking proposals from qualified firms, hereinafter referred to as the Contractor, to provide the Chromebooks, Carts and Google Chrome Management Licenses for the City of Pembroke Pines Charter Schools.

# (F) RE-19-12 "Design Build Services for the Construction of a Recreation Center at William B. Armstrong Park"

The City of Pembroke Pines is seeking qualification statements from qualified firms, with specialized skills and interest in providing professional services for a Design/Build project to

construct a new Recreation Center at the William B. Armstrong Dream Park.

### (G) Boiler Plate

This attachment is the standard boiler plate language that is used for the solicitations listed above. It is attached to this agenda item separate from the solicitations to reduce the repetition of this item.

### FINANCIAL IMPACT DETAIL:

#### (A) PSPW-19-07 "Construction of Raintree Park"

On 12/21/2011, Commission approved the Hoyer Homes LLC Agreement to purchase 32.9 Acres of the Raintree Property for a purchase price of \$3,100,000. As part of this sale agreement, \$450,000 was contributed by the developer (Hoyer Homes LLC) for the linear park improvements at the Raintree Property. After the bids are received and evaluated an agenda item will be brought to Commission for approval, which will include a budget adjustment to move the available project funds that has been contributed by the developer to account # 320-572-7001-63056 (Linear Park).

### (B) PSUT-19-03 "Water Treatment Facility Improvements"

Funds are available in account # 471-533-6031-63000 (Water Utility Services, Improvement other than building)
