SUMMARY EXPLANATION AND BACKGROUND:

1. On March 7, 2018, the City Commission authorized the advertisement of PD-18-03 "Mobile Surveillance Tower Platform", which was advertised on March 13, 2018.

2. The purpose of this solicitation was to provide the Pembroke Pines Police Department with a Mobile Surveillance Tower Platform.

3. On April 10, 2018, the City opened three (3) proposals from the following vendors:

Vendor Name	Total Cost
Mobile Pro Systems	\$62,439.00
Vetted Security Solutions	\$84,974.00
FLIR Systems	\$196,096.95

4. The lowest priced vendor, Mobile Pro Systems, did not meet all the specifications as outlined by the Police Department. Specifically, the gas tank proposed is ten (10) gallons

smaller than what the bid specified which will impact deployment duration time. Also, the specifications required a 600W Power Inverter, and Mobile Pro Systems proposed a 150 Watt Inverter which they stated "works for application/upgradable". Mobile Pro Systems also included a line item for a camera license service agreement for a (1) one year period, which would have a recurring yearly fee. Camera licensing on mobile surveillance tower platforms is not required by the competitor vendors. Due to these findings the Police Department has deemed the proposal from Mobile Pro Systems as non-responsive.

5. The Police Department has reviewed the proposals and has deemed Vetted Security Solutions to be the most responsive/responsible proposer.

6. In addition, Vetted Security Solutions has also completed the Equal Benefits Certification Form and has stated that the "Contractor currently complies with the requirements of this section."

7. Request Commission to award PD-18-03 "Mobile Surveillance Tower Platform" to the most responsive/responsible bidder, Vetted Security Solutions in the amount of \$84,974.
