Pembroke Pines Police Department Red Light Camera Report

Key Points

A national study shows that cities that adopt a red light camera program experience 21% less fatal traffic crashes at intersections with red light cameras.

Pembroke Pines traffic crashes have reduced by at least 16% at intersections with red light cameras.

Most citations go to non-residents of Pembroke Pines, 68%.

The percentage of Pembroke Pines Residents issued red light camera citations has gone down from 36% in Feb. 2019 to 32% by Feb. 2020.

For the one year period ending on Feb. 2020, only 2.81% of all the notices of violation were sent to vehicles registered to addresses in Century Village.

In 2019, 1 out of 200 vehicles was cited (0.05%). In 2020, approximately 1 out 250 vehicles was issued a citation (0.04%).

The City of Pembroke Pines Red Light Camera Program currently generates revenue above operational costs.

Red light cameras can assist investigating crashes, solving crimes, and locating missing persons. They also provide live access that can be used to monitor traffic or conduct investigations.



"In 2018, 846 people were killed in crashes that involved red light running" (IIHS).

Introduction

This report is a summary of information related to the City of Pembroke Pines Police Department's Red Light Camera Program. The data contained herein includes information related to traffic crashes, citations issued, revenue obtained, and the financial impact associated with the program. This report has been created with information provided by Susan Shechter, Valerie Spotts, Faizal Mohammed, and Tracey Julien-Lewis.

Notices of Violation

Statistics generated by the Redflex system show an increase in the annual number of Notices of Violation (NOV) issued in the last two years, from 14,146 to 18,052. The time periods measured are 3/1/2018 to 2/28/2019, and 3/1/2019 to 2/29/2020. However, the cameras also show an increase in traffic volume at the intersections selected from 46.48 million vehicles in the beginning of 2019 to 48.98 million vehicles in the beginning of 2020. Thus, even though more citations were issued during the latter time period, a smaller percentage of vehicles were actually cited for running the red light.

New Cameras

Possible locations for new cameras include heavily traveled intersections such as Pines Blvd. and University Dr., and Pines Blvd. and Hiatus Rd. A study conducted by Redflex showed that some of the intersections with the highest number of expected violations are southbound on University Dr. and Pembroke Rd., eastbound on Pines Blvd. and University Dr., northbound on Pines Blvd. and Hiatus Rd., and eastbound on Pines Blvd. and 72 Ave.

The data shows that 10.37% of the NOVs issued between Mar. 2018 and Feb. 2019 were sent to a Century Village address. That number went down to 2.81% for the time period between Mar. 2019 and Feb. 2020.

Notices of Violation (Cont.)

During the time period ending in February 2019, 0.05% of the vehicles that traveled through the intersections were issued an NOV (14,146 out of 46.48 million). And, during the year ending in February 2020, only 0.04% of the vehicles that traveled through the intersections were issued an NOV (18,052 out of 48.98 million). This percentage indicates that roughly 1 out 250 vehicles that traveled by a red light camera between March 2019 and February 2020 was issued a NOV.

It should be noted that in July, 2019, the Red Light Camera program ceased to issue citations to drivers traveling north bound on SW 136 Ave. and making a right turn onto Pines Blvd., from the outside turning lane.

Impact on Pembroke Pines Residents

Regarding the impact of the red light cameras on Pembroke Pines residents, the data shows that the percentage of citations issued to Pembroke Pines residents has been consistently going down. At the beginning of 2018, the percentage was 36%, but that number then dropped to 32% by the beginning of 2020.



There was a 13% drop on the percentage of Pembroke Pines residents that are repeat offenders. During the time period of Mar. 2018 – Feb. 2019. 54% of the NOVs were issued to Pembroke Pines residents. This percentage dropped to 41% during the Mar. 2019 – Feb. 2020 time period.

Traffic Crashes

A review of traffic accidents, including all intersections that currently have at least one red light camera, indicates that the number of crashes at those intersections has decreased since the cameras were installed. During the year that the cameras were first installed (3/2017 - 2/2018) there were a total of 364 crashes reported at those intersections. However, during the past year (3/2019 - 2/2020), the number of crashes dropped to 306. This indicates a 16% reduction in crashes. It should be noted that traffic volume has increased during the past two years. Therefore, this reduction is likely higher.

In 2019, the cost of personnel associated with the Red Light Program was \$366,051.00, this included a Police Service Aide, a Coordinator, and a Police Officer. The Traffic Sergeant currently assigned to the west side of the City oversees the RLC Unit at no additional cost to the program. This year, the Police Officer position has been replaced with a Police Service Aide, which will drive the cost of personnel down for 2020. Operating costs for 2019 were \$417,989.00. This means that during 2019, the total cost to the City to operate the program was \$784,040.00. However, the revenue generated was \$928,764.00, which produced a Net Surplus of \$144,724.00.
