A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA, AMENDING THE CITY'S CITIZENS PARTICIPATION PLAN PUBLIC COMMENT PERIOD AND THE IN-PERSON MEETING REQUIREMENT FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM ("CDBG"); PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Pembroke Pines (the "City"), has been designated as an "Entitlement City" by the United States Department of Housing and Urban Development ("HUD"), which entitles the City to receive an annual allocation of Community Development Block Grant ("CDBG") funds directly from HUD to implement housing and community development projects throughout the City; and

WHEREAS, The City has received an additional allocation of funds related to the CARES Act to combat COVID-19; and

WHEREAS, In order to receive these funds, the City must amend its Citizens Participation Plan; and

WHEREAS, Given the need to expedite actions to respond to COVID-19, HUD waived 24 CFR 91.105 (c)(2) and (k), 91.115(c) (2) and (i) in order to balance the need to respond quickly to the growing spread and effects of COVID-19 with the statutory requirement to provide reasonable notice and opportunity for citizens to comment on substantial amendments concerning the proposed uses of CDBG, HOME, HTF, HOPWA, or ESG funds; and

WHEREAS, certain in-person meetings are not required under Florida

Statutes and State Executive Orders, related to the COVID-19 pandemic; and
