SUMMARY EXPLANATION AND BACKGROUND:

1. Pursuant to Section 35.29(F) "City Commission notification" of the City's Code of Ordinances, "The City Manager, or his or her designee, shall notify the Commission, in writing, at least three months in advance of the expiration, renewal, automatic renewal or extension

date, and shall provide a copy of the contract or agreement and a vendor performance report card for the contract or agreement to the City Commission."

2. On May 17, 2017, Commission approved the motion to place all contracts from the Contract Database Reports on consent agendas as they come up for contractual term renewal so that City Commission affirms directions to administration whether to renew or to go out to bid.

3. The Agreement shown below is listed on the March, 2019 Contracts Database Report.

(A) Trane U.S., Inc. - Maintenance of Air Cooled Chillers at Academic Village and the "U" Building

1. The City of Pembroke Pines Academic Village Campus entered into an Extended Warranty Service Agreement with Trane U.S. Inc. for an initial three (3) year period commencing on December 1, 2000 and ending on November 30, 2003.

2. To date, the agreement has had twelve (12) one (1) year renewals, the last of which was renewed on April 4, 2018 in combination with the City of Pembroke Pines "U" Building Agreement and the terms were extended to June 30, 2019.

3. The City of Pembroke Pines "U" Building located at Academic Village entered into an Extended Warranty Service Agreement with Trane U.S. Inc. for an initial three (3) year period commencing on August 1, 2003 and ending July 31, 2006.

4. To date, the agreement has had nine (9) one (1) year renewals, the last of which was renewed on April 4, 2018 in combination with the City of Pembroke Pines "U" Building Agreement and the terms were extended to June 30, 2019.

5. The Academic Village now uses Trane U.S. Inc. for the maintenance of the Air-Cooled Chillers located in the buildings campus-wide.

6. The City of Pembroke Pines Public Services Department recommends that the City renew the existing combined Agreement for an additional one (1) year term, commencing on July 1, 2019 and ending on June 30, 2020.

1. Pursuant to Section 35.29(F) "City Commission notification" of the City's Code of Ordinances, "The City Manager, or his or her designee, shall notify the Commission, in writing, at least three months in advance of the expiration, renewal, automatic renewal or extension date, and shall provide a copy of the contract or agreement and a vendor performance report card for the contract or agreement to the City Commission."

2. On May 17, 2017, Commission approved the motion to place all contracts from the Contract Database Reports on consent agendas as they come up for contractual term renewal so that City Commission affirms directions to administration whether to renew or to go out to bid.

3. The Legislative items shown below are on the April 2018 Contract Database Report, and based on the 90 day requirement, these Agreements are being presented to Commission for approval.

(A) Trane U.S. Inc. - Maintenance of Air Cooled Chillers

Academic Village

1. The City of Pembroke Pines Academic Village Campus entered into an Extended Warranty Service Agreement with Trane U.S. Inc. for an initial three (3) year period commencing on December 1, 2000 and ending on November 30, 2003.

2. Academic Village utilizes Trane U.S. Inc. for the maintenance of the Air-Cooled Chillers located on its campus.

3. To date, the agreement has had eleven (11) amendments, including eleven (11) one (1) year renewals which extended the term of the agreement to June 30, 2018.

4. Trane U.S. Inc. currently services the entire Academic Village. This renewal will amend the Original Agreement and combine all locations into one formal agreement.

5. The City of Pembroke Pines Public Services Department recommends that the City renew this Agreement for an additional one (1) year term, commencing on July 1, 2018 and expiring June 30, 2019, as allowed by the agreement.

Academic Village (U Building)

1. The City of Pembroke Pines "U" Building Located at Academic Village entered into an Extended Warranty Service Agreement with Trane U.S. Inc. for an initial three (3) year period commencing on August 1, 2003 and ending July 31, 2006.

2. The "U" Building at Academic Village utilizes Trane U.S. Inc. for the maintenance of the Air-Cooled Chillers located at its building.

3. To date, the agreement has had eight (8) amendments, including eight (8) one (1) year renewals which extended the term of the agreement to June 30, 2018.

4. Trane U.S. Inc. currently services entire Academic Village. This renewal will amend the

Original Agreement and combine all locations into one formal agreement.

5. The City of Pembroke Pines Public Services Department recommends that the City renew its Agreement for an additional one (1) year term, commencing on July 1, 2018 and expiring June 30, 2019, as allowed by the agreement.

(B) Martin Gold Coast LLC - Bus Bench and Shelter Advertising License

1. On June 18, 2008, the City Commission approved to enter into a Franchise Agreement with Martin Gold Coast LLC, for an initial five (5) year period commencing on August 1, 2008 and ending on July 31, 2013.

2. The City of Pembroke Pines Utilities Department utilizes Martin Gold Coast LLC to furnish, maintain and install benches and bus shelters displaying advertisements throughout the City of Pembroke Pines.

3. Pursuant to Section 4.2 of the Original Agreement, this agreement shall be renewable, upon mutual consent of the parties, for one (1) additional five (5) year term.

4. To date, the agreement has had two (2) Amendments, including one (1) five (5) year renewal which extended the term of the agreement to July 31, 2018.

5. On February 21, 2018, the City Commission approved the First Amendment which included initial refurbishment and ongoing maintenance of the sixteen (16) additional bus shelters provided by Broward County.

6. This agreement is currently in the final renewal period, therefore the Public Services Department will start the procurement process for these services.

(C) NC4 Public Sector LLC - Purchase of Crime Fighting Software Package to Assist Officers in Combatting Crime

1. On August 5, 2015, the City Commission approved to enter into Software License and Management Services Agreement for an initial three (3) year period commencing on August 20, 2015 and ending on August 19, 2018.

2. The City of Pembroke Pines Police Department utilizes NC4 Public Sector LLC for the officers to have the capability to create real time crime bulletins for a wanted subject or missing person which includes photographs and video.

3. Pursuant to Section 12.1 of the Original Agreement, this agreement shall renew in yearly or greater increments upon written notice by Customer of its intent to renew upon thirty (30) days prior to the end of any term.

4. The City of Pembroke Pines Police Department recommends that the City renew this Agreement for an additional one (1) year term, commencing on August 20, 2018 and expiring August 19, 2019, as allowed by the agreement.

(D) Wells Capital Management, Incorporated - Investment Management Services

4. To date, this Agreement has had three (3) amendments, including two (2) two (2) year renewals, extending the term of the agreement to February 14, 2019.

5. On July 5, 2016, the City entered into the Second Amendment which replaced Exhibit C - Fee Schedule of the Original Agreement, resulting in a decrease in the fee from 0.10% to 0.085% based on market value of assets.

6. This Agreement is in its final renewal period, therefore the Finance Department will start the procurement process for these services.




