Subject: Dispatch Information

Chief Picarello:

I wanted to reach out to you sooner, but with the unfortunate passing of DE Mehaffey. It was important to me to give you and the Fire Department some time to grieve and focus on the family needs during this difficult time.

Back in April 2019, I presented an item regarding the current status of dispatch for the County.

Tracy Jackson and his colleagues from the County were in attendance that evening if any questions had arose.

I want an item placed on the June 17th agenda to present to our community regarding the improvements that have been made over the past year. This presentation at our Commission meeting should be conducted by a member assigned by the Sheriff's office. It would be great to have Sheriff Tony in attendance to address our Commission as he has done in BSO contracted cities.

As you may recall, changes were implemented by the former Sheriff Scott Israel without properly communicating these changes with the County. As a result, Mr. Tracy Jackson convened a meeting with our Administration and myself in January 2019. At that private meeting, it was determined that performance results were the most frightening and concerned data we had received to date.

As a result of the meeting, Mr. Jackson asked for a few weeks to figure out what to do next. After consulting with Mr. Jackson, I placed the item in front of the Pembroke Pines Commission to ensure that I was not going alone with this grave concern.

Chief, please request the P1/P2 & P3 data for the timeframe of January 2019 through April 2020.

This data, once received and reviewed by you and I, I will place the information as a Commissioner Item for discussion on June 17th.

I don't expect a long turnaround time for the information requested. I have copied Sheriff Tony and his Administration to expedite this request.

From everything that I have seen and heard from our PD/FD, improvements have been made since the April 2019 presentation.

I want to thank you in advance for your assistance. Together we will make a positive difference for all Broward County Citizens.
