WHEREAS, HUD requires all entitlement jurisdictions to submit a Consolidated Plan and Action Plan in order to receive CDBG funding; and

WHEREAS, the Consolidated Plan will be effective for a five year time period; and

WHEREAS, the 2020-2024 Consolidated Plan and 2020-2021 Action Plan were noticed in compliance with the City's Citizen Participation Plan, as amended by the City Commission; and

WHEREAS, the City Commission finds that approving the 2020-2024 Consolidated Plan and 2020-2021 Action Plan is in the best interest of the health, safety, and welfare of the citizens and residents of the City.
