A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES. FLORIDA APPROVING THE DESIGN AND INSTALLATION OF DECORATIVE WRAPS ON FOURTEEN (14) SIGNALIZATION CABINETS LOCATED AT THE CORNERS OF PINES BOULEVARD AND FLAMINGO ROAD (3 CABINETS AT THIS LOCATION), PALM AVENUE AND TAFT STREET (2 CABINETS AT THIS LOCATION). PINES BOULEVARD AND UNIVERSITY DRIVE (2) CABINETS AT THIS LOCATION), PEMBROKE ROAD AND 72ND AVENUE (1 CABINET AT THIS LOCATION), PEMBROKE ROAD AND UNIVERSITY DRIVE (1 CABINET AT THIS LOCATION), HIATUS ROAD AND JOHNSON STREET (1 CABINET AT THIS LOCATION), PINES BOULEVARD AND 145TH AVENUE (1 CABINET AT THIS LOCATION), PINES BOULEVARD AND 172ND AVENUE (1 CABINET AT THIS LOCATION), PINES BOULEVARD AND 196TH AVENUE (1 CABINET AT THIS LOCATION). SHERIDAN STREET AND 184TH AVENUE (1 CABINET AT THIS LOCATION). APPROVING THE COMMUNITY AESTHETIC FEATURE AGREEMENT (CAFA) BETWEEN THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) AND THE CITY ATTACHED AS EXHIBIT A: DIRECTING APPROPRIATE CITY OFFICIALS TO TAKE ON ANY AND ALL ACTION NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION: PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City's Arts and Culture Advisory Board is a seven member board which promotes art in public places throughout the City;

WHEREAS, pursuant to a recommendation by the Arts and Culture Board, the City is seeking to build a cultural infrastructure that celebrates and uses the arts as an effective strategy for increasing economic activity; and

WHEREAS, the City has implemented a program that utilizes a vinyl product to wrap fourteen (14) signalization cabinets to reflect the theme of the Pembroke Pines-Happiest City in South Florida 2019, according to Wallethub; and

WHEREAS, the fourteen (14) signalization cabinets are located at ten (10)

different locations on Pines Boulevard and Flamingo Road (3 cabinets at this location), Palm Avenue and Taft Street (2 cabinets at this location), Pines Boulevard and University Drive (2 cabinets at this location), Pembroke Road and 72nd Avenue (1 cabinet at this location), Pembroke Road and University Drive (1 cabinet at this location), Hiatus Road and Johnson Street (1 cabinet at this location), Pines Boulevard and 145th Avenue (1 cabinet at this location), Pines Boulevard and 172nd Avenue (1 cabinet at this location), Pines Boulevard and 196th Avenue (1 cabinet at this location), Sheridan Street and 184th Street (1 cabinet at this location); and

WHEREAS, other cities in Broward County have successfully implemented a similar program; and

WHEREAS, the cost for the installation is \$780.00 per large cabinet (10 large cabinets) and \$629.00 per small cabinet (4 small cabinets) to include surveys, cleaning and preparation of the cabinets and installation for a total amount of \$10,316.00; and

WHEREAS, the artistic design to be featured on the signalization cabinets was approved by the Arts & Culture Advisory Board; and

WHEREAS, FDOT requires that a Community Aesthetic Feature Agreement (CAFA) be executed prior to installing the decorative wraps, as attached hereto as Exhibit "A."

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA THAT:

SECTION 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as true and correct and by this reference incorporated herein.

SECTION 2. That the City Commission hereby approves the installation of decorative vinyl wrap on fourteen (14) signalization cabinets located at ten (10) locations, as specifically depicted in Exhibit "B" attached hereto and incorporated herein by reference.

SECTION 3. The City Commission hereby approves and authorizes the appropriate City administrators to execute the attached Community Aesthetic Feature Agreement (CAFA) between the State of Florida Department of Transportation (FDOT) and the City, together with such non material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.

SECTION 4. All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5. If any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or application, it shall not affect the validity of the remaining portions or applications of this Resolution.

SECTION 6. This Resolution shall become effective immediately upon adoption.
