SUMMARY EXPLANATION AND BACKGROUND:

The City of Pembroke Pines is seeking proposals from qualified firms, hereinafter referred to as the Contractor, to install new metal and vinyl canopies at different locations.

The City of Pembroke Pines is seeking proposals for a Pour In Place surface at the City of Pembroke Pines West Campus Charter Elementary.

The City of Pembroke Pines is seeking proposals from qualified firms to replace the current iFix Supervisory Control and Data Acquisition (SCADA) system with a new VTSCADA system at the City's Waste Water Treatment Facility located at 13975 Pembroke Road, Pembroke Pines, FL 33027.
