Randy,

As a follow-up to our conversation today and your inquiry about annual price adjustments, the FSA20-VEL28.0 Pursuit, Administrative, and Other Vehicles Contract, Section 3.04 provides for annual price adjustments based on the US Bureau of Labor Statistics PPI, manufacturer certifications, and other variables on an annual basis. Under this contract, annual price adjustments for the Traverse and Tahoe vehicles you inquired about have been reviewed and approved by FSA as follows:

- Bid Item 284: Traverse 2WD LS – **5% price adjustment**
- Bid Item 330: Traverse AWD LS – **4.5% price adjustment**
- Bid Item 329: Tahoe – **5.8% price adjustment**
