MOTION TO APPROVE THE UPDATED 2021-22 MENTAL HEALTH SERVICES PLANS AND THE POLICY AND PROCEDURES FOR NOTIFICATIONS OF INVOLUNTARY EXAMINATIONS FOR THE CITY OF PEMBROKE PINES CHARTER ELEMENTARY SCHOOLS (LOCATION #5051), MIDDLE SCHOOLS (LOCATION #5081), HIGH SCHOOL (LOCATION #5121) AND FSU ELEMENTARY CHARTER SCHOOL (LOCATION #0351).

**SUMMARY EXPLANATION AND BACKGROUND:**

1. On May 19, 2021, City Commission approved the 2021-2022 charter school Mental Health Service Plans for the City of Pembroke Pines Charter School Locations 5051-Elementary Schools, 508- Middle Schools, 5121- Academic Village Charter School and 0351- FSU Elementary-Broward Lab School (See Exhibit 1. 2021-2022 MHP, MHP Audit, PPCS Opt Out Forms Governing Board Approval). Charter schools are required to submit Mental Health Plans annually prior to receiving Mental Health Assistance funding.

2. Since the initial City Commission approval, the Florida Department of Education released a new Mental Health Plan template. The new template merges the applications of two mental health programs into one application - the Youth Mental Health Awareness Training Plan (YMHAT) and the Mental Health Assistance Allocation Plan (MHAA). The new template is titled FLDOE 2021-2022 Mental Health Application (MHA) (See Exhibit 2. 2021-22 FSU Broward Lab MHA, Exhibit 3. 2021-22 CPP Charter Elementary Schools YMHAT-MHAA 5051, Exhibit 4. 2021-22 CPP Charter Middle Schools YMHAT-MHAA 5081, and Exhibit 5. 2021-22 CPP Charter High Schools YMHAT-MHAA 5121).

3. Part I of the new MHA addresses the YMHAT program. This program supports the training of school personnel to identify and understand various mental health issues that affect today's youth. The FLDOE is currently finalizing the funding allocation for this program, thus the revenue amounts per charter school have not been released.

4. Part II of the new MHA addresses the Mental Health Assistance Allocation Plan. The data asked for in this section is similar to the Mental Health Services Plans City Commission approved on May 19, 2021. As stated in the prior plan approval, the City of Pembroke Pines Charter Schools are projected to receive a proportionate share of these funds. The estimated allocation breakdown is below:

Location 5051- Elementary Schools	\$75,301
Location 5081- Middle Schools	\$52,915
Location 5121- High School (Academic Village)	\$83,236
Location 0351- FSU Elementary *	\$127,899
Total Estimated Allocation:	\$339,351

\* The FSU sponsored Elementary School is categorized as its own district, hence receiving the base allocation of \$100,000 plus the additional funding for the FTE proportion. The School Board of Broward County (SBBC) sponsored Charter Schools will receive a portion of the SBBC's projected FY 2021-22 allocation, \$10,455,580, based on its FTE proportion.

5. In addition, the Florida Legislature passed Senate Bill 590 (attached as Exhibit 6) to be effective on July 1, 2021 which amended Florida Statute 1002.33 (9) to require each charter school governing board to develop a policy and procedures for parent or guardian notification requirements before an involuntary examination of a minor. School Administration and the City Attorney's Office have produced the required system-wide Policy and Procedures for Notification of Involuntary Examinations, see attached Exhibit 7.

6. Recommend the City Commission to approve the updated 2021-22 Mental Health Services Plans and the Policy and Procedures for Notification of Involuntary Examinations for the City of Pembroke Pines Charter Elementary schools (Location #5051), Middle schools (Location #5081), High School (location #5121) and FSU Elementary Charter School (Location #0351).
