COMMISSIONER CASTILLO - ITEM 1: MOTION TO DISCUSS AND TAKE POSSIBLE ACTION ABOUT CONTRACT LANGUAGE GOVERNING AGREEMENT WITH WEST PINES UNITED, TRAVEL SOCCER LEAGUE, WHICH PLAYS GAMES AT CHAPEL TRAIL PARK AND SILVER LAKES PARK NORTH, SPECIFICALLY THE PUBLIC RECORDS ISSUE INVOLVING CHILDREN'S (PLAYER'S) NAMES AND PERSONAL INFORMATION, AND LEAGUE BYLAWS REGARDING SELECTION OF BOARD MEMBERS. PRESENTATION BY LEAGUE OFFICIALS AND PARENTS.

Commission Item #17 was taken out of order and addressed at the start of the meeting.

Christina Sorensen, Recreation and Cultural Arts Director/Assistant City Manager addressed the Commission about the West Pines United FC Soccer Club. Ms. Sorensen discussed updates made to the existing program with regards to the club's by-laws and rosters. The names and dates of birth for each of the players would be excluded from the roster. The email addresses, phone numbers, and the parents' information would remain on the roster as required for compliance in the City's by-laws.

Item 17 was taken out of order without objection.

Commissioner Castillo read Item 17 into the record by title and spoke about a solution to resolve any issues with the West Pines United FC Soccer Club team roster.

Commissioner Schwartz, Commissioner Siple, and Mayor Ortis spoke on the item.

Deputy City Attorney Horowitz addressed the Commission. He spoke about compliance requirements in the City's by-laws. The only information that would be excluded from public records are the players' names and their dates of birth. Mr. Horowitz also referenced the statute regarding government sponsored programs and further explained that the city does not sponsor the West Pines United FC Soccer Club.

Christina Sorensen, Recreation and Cultural Arts Director/Assistant City Manager, spoke about public record requests for roster information. She said that all the youth sport organizations will have the same agreement as West Pines United FC extended to them in October when their contracts are up for renewal. Ms. Sorensen said there will be a requirement to have the minutes of each club accessible via public records request.
