MOTION TO APPROVE THE AGREEMENT BETWEEN THE CITY OF PEMBROKE PINES AND RENAISSANCE CHARTER SCHOOL TO PROVIDE A POLICE OFFICER TO SERVE AS A SCHOOL RESOURCE OFFICER AT THE RENAISSANCE CHARTER SCHOOL IN PEMBROKE PINES AND FOR RENAISSANCE CHARTER SCHOOL TO PAY THE FULL COST OF \$79,398 FOR THE RESOURCE OFFICER.

SUMMARY EXPLANATION AND BACKGROUND:

1. The School Resource Officer Agreement between the City and Renaissance Charter School calls for the City to assign a Police Officer as a School Resource Officer (SRO) at the Renaissance Charter School in Pembroke Pines (10501 Pines Blvd). Renaissance Charter School agrees to pay the City the sum of \$79,398 for the services provided by one (1) Officer.
2. The term of the agreement is from July 1, 2020 through June 30, 2021.
3. The City will receive \$79,398 and this revenue will be credited to account #1-342120-3001-303; School Resource Officer (SRO).
4. The estimated expenditure for one School Resource Officer is as follows:

Full cost of one (1) officer = \$79,398

Revenue for one (1) SRO officer from Renaissance Charter School = \$79,398

Net = \$0
5. The agreement has been reviewed and approved as to legal form by the Police Legal Advisor.
6. Request Commission approval on School Resource Officer agreement between the City and Renaissance Charter School.
