MOTION TO APPROVE THE PURCHASE OF FIRE RESCUE MEDICAL SUPPLIES AND EQUIPMENT FROM HENRY SCHEIN FOR A TOTAL AMOUNT NOT TO EXCEED \$38,710, UTILIZING THE SAVVIK BUYING GROUP CONTRACT #202102, FROM MEDLINE INDUSTRIES, INC. FOR A TOTAL AMOUNT NOT TO EXCEED \$29,470, UTILIZING THE SAVVIK BUYING GROUP CONTRACT #202102 FOR FISCAL YEAR 2021-2022 PURSUANT TO SECTION 35.18(C) (6) OF THE CITY'S CODE OF ORDINANCES.

PROCUREMENT PROCESS TAKEN:

- Chapter 35 of the City's Code of Ordinance is titled "PROCUREMENT PROCEDURES, PUBLIC FUNDS."
- Section 35.18 of the City's Code of Ordinances is titled "COMPETITIVE BIDDING OR COMPETITIVE PROPOSALS REQUIRED; EXCEPTIONS."
- Section 35.18(C) states that "Only the following situations are exempt from the competitive bid and competitive proposal requirements of this section:"
- Section 35.18 (C)(6) states that "Cooperative purchasing plans are exempt from this section."
- Section 35.21 of the City's Code of Ordinances is titled "AWARD OF CONTRACT."
- Section 35.21(A) of the City's Code of Ordinances is titled "City Commission approval."
- Section 35.21(A)(1) states, "An initial purchase of, or contract for, commodities or services, in excess of \$25,000, shall require the approval of the City Commission, regardless of whether the competitive bidding or competitive proposal procedures were followed."

SUMMARY EXPLANATION AND BACKGROUND:

1. The City of Pembroke Pines Fire Department is requesting the authorization to purchase Fire Rescue Medical Supplies and Equipment for fiscal year 2021-2022 from:

- 3. On April 1, 2021, Eagle County Paramedic Services, as lead agency for Savvik Buying Group, entered into a three (3) year agreement commencing on June 1, 2021 with the option to renew for one (1) additional two (2) year period with Henry Schein.
- 4. On April 1, 2021, Eagle County Paramedic Services, as lead agency for Savvik Buying Group, entered into a three (3) year agreement commencing on June 1, 2021 with the option to renew for one (1) additional two (2) year period with Medline Industries, Inc.
- 5. Request Commission to approve the purchase of fire rescue medical supplies and equipment from Henry Schein for a total amount not to exceed \$38,710, utilizing the Savvik Buying Group contract #202102, from Medline Industries, Inc. for a total amount not to exceed \$29,470, utilizing the Savvik Buying Group contract #202102 for fiscal year 2021-2022 pursuant to Section 35.18(c)(6) of the City's Code of Ordinances.
