SUMMARY EXPLANATION AND BACKGROUND:

This project is federally funded by the American Rescue Plan Act (ARPA) and thus will follow Federal Procurement guidelines.

(B) TS-21-11 "Sophos Antivirus Renewal for Charter Schools"

The City of Pembroke Pines is seeking proposals from qualified firms to provide the requested Sophos annual renewal licenses for the City of Pembroke Pines' Charter Schools.

The requested Sophos renewal licenses provides support and maintenance for the City of Pembroke Pines. Sophos is the City's endpoint (antivirus) protection.

Renewal will be for the following Sophos endpoint protection products:

Intercept-X Advanced with XDR (CAEM1ETAA) - Intercept X consolidates powerful extended detection and response (XDR) with next-gen endpoint protection.

Intercept-X Advanced with XDR for Servers (CSIG1ETAA) - Intercept X for Server consolidates powerful extended detection and response (XDR) with next-gen Server protection. Agents are designed specifically for Server infrastructure - whether it be physical, virtual, on premise, or cloud-hosted.

ExaGrid is the City's data backup storage and replication hardware solution.

Veeam is the City's data backup and replication software solution.
