MOTION TO APPROVE THE AGREEMENT BETWEEN LEXIPOL, LLC AND THE PEMBROKE PINES POLICE DEPARTMENT FOR THE CORDICOSHIELD LAW ENFORCEMENT WELLNESS APP IN THE AMOUNT NOT TO EXCEED \$35,000, PURSUANT TO SECTION PURSUANT TO SECTION 35.18(C)(7)(H) OF THE CITY'S CODE OF ORDINANCES..

## PROCUREMENT PROCESS TAKEN:

- Chapter 35 of the City's Code of Ordinances is titled "PROCUREMENT PROCEDURES, PUBLIC FUNDS."
- Section 35.18 of the City's Code of Ordinances is titled "COMPETITIVE BIDDING OR COMPETITIVE PROPOSALS REQUIRED; EXCEPTIONS."
- Section 35.18(C) states that "Only the following situations are exempt from the competitive bid and competitive proposal requirements of this section:"
- Section 35.18(C)(7)(h) states, "Copyrighted materials, including computer software;"
- Section 35.21 of the City's Code of Ordinances is titled "AWARD OF CONTRACT."
- Section 35.21(A) of the City's Code of Ordinances is titled "City Commission approval."
- Section 35.21(A)(1) states, "An initial purchase of, or contract for, commodities or services, in excess of \$25,000, shall require the approval of the City Commission, regardless of whether the competitive bidding or competitive proposal procedures were followed."

## **SUMMARY EXPLANATION AND BACKGROUND:**

- 1. This item is a proposed agreement with Cordico/Lexipol software wellness mobile application for (1) year at a cost of \$35,000, to be used by the Police Department
- 2. The app will contain a variety of content and features pertaining to law enforcement mental and physical health wellness topics, including but not limited to: critical incidents, family support, grief and loss, stress management, physical fitness, nutrition.
- 3. The cost will be 100% funded by a federal grant. The wellness app will be made available for use by all Pembroke Pines Police sworn and civilian employees.
